SUBJECT:	AMENDMENTS TO THE TRAFFIC AND PARKING BY-LAW

#### RECOMMENDATION

That on the recommendation of the Managing Director, Environmental & Engineering Services and City Engineer the following actions **BE TAKEN**:

- a) The proposed by-law, attached as Appendix A BE INTRODUCED at the Municipal Council meeting to be held on July 26, 2017 for the purpose of amending the Traffic and Parking By-law (PS-113);
- b) The proposed by-law, attached as Appendix B **BE INTRODUCED** at the Municipal Council meeting to be held on July 26, 2017 for the purpose of amending the Traffic and Parking By-law (PS-113) in order to implement 'No Stopping Anytime' zones in the vicinity of the London International Airport for Airshow London 2017 from September 22 to September 24; and
- c) The proposed by-law, attached as Appendix C **BE INTRODUCED** at the Municipal Council meeting to be held on July 26, 2017 for the purpose of amending the Traffic and Parking By-law (PS-113) in order remove the 'No Stopping Anytime' zones previously approved for Airshow London 2017.

#### 2015-19 STRATEGIC PLAN

The following report supports the Strategic Plan through the strategic focus area of **Strengthening Our Community** by improving safety, traffic operations and residential parking needs in London's neighbourhoods.

### **BACKGROUND**

The Traffic and Parking By-law (PS-113) requires amendments (Appendix A, B & C) to address traffic safety, operations and parking concerns. The following amendments are proposed:

#### 1. No Stopping

### a) Airshow London 2017

Staff received a request from the Airshow London 2017 organizers, London Police Services and the Parking Office to implement 'No Stopping Anytime'

zones on key streets near the London International Airport during the show. In 2016 drivers ignored the 'No Parking Anytime' signs and the directions of London Police Services to not park within certain areas. The request cites safety concerns for drivers and pedestrians on roadways near the London International Airport while the airshow is in operation. The changes are to be in place from September 22<sup>nd</sup>, 2017 to September 24<sup>th</sup>, 2017. The 'No Stopping Anytime' signs will be removed after September 25<sup>th</sup>, 2017. The following are the recommended temporary 'No Stopping Anytime' zones:

- Both sides of Creamery Road north from Dundas Street to the north limit of Creamery Road;
- Both sides of Dundas Street from Crumlin Sideroad to the east City limit;
- Both sides of Evelyn Drive from Rebecca Road to the east City limit;
- Both sides of Kostis Avenue from Dundas Street to north limit;
- Both sides of Rebecca Road from Robin's Hill Road to Evelyn Drive; and
- Both sides of Robin's Hill Road from Crumlin Sideroad to Huron Street.

The London Police Services will close Crumlin Sideroad and Robin's Hill Road north of Huron Street during Airshow London 2017.




Figure 1: Temporary 'No Stopping Anytime' zones for Airshow London 2017

b) The construction of apartment buildings at 1235 Richmond Street and 1265 Richmond Street are complete and a review of the traffic operations has determined that vehicles stopping in front of these buildings during morning peak hours is causing traffic flow and safety concerns. It is recommended to implement a 'No Stopping 7:00 a.m. to 9:00 a.m.' zone on the west side of Richmond Street from 1235 Richmond Street to 1265 Richmond Street.




Figure 2: 1235 to 1265 Richmond Street

Amendment are required to Schedule 1 (No Stopping) and Schedule 2 (No Parking) for the above changes.

### 2. No Parking

a) Plant Matter Kitchen at 162 Wortley Road has received the necessary approvals and permits to operate a patio outside their business on the city's road allowance. In order to accommodate the patio a 'No Parking Anytime' zone adjacent to the patio is required to replace the existing '1 Hour Limited Parking, 8:00 a.m. to 6:00 p.m.' zone. The remaining '1 Hour Limited Parking 8:00 to 6:00 p.m.' zone south to Elmwood Avenue E will be unaffected.

b) It is recommended to implement a 'No Parking Anytime' zone within the limits of the centre traffic island on Dalmagarry Road south of Fanshawe Park Road W.




Figure 4: Dalmagarry Road south of Fanshawe Park Road W

c) At its March 2, 2017 session, Municipal Council approved the following resolution:

That the following actions be taken with respect to the installation of sidewalks on East Mile Road, Oban Crescent, West Mile Road, North Mile Road, and Green Lane:

- a) curbface sidewalks BE IMPLEMENTED throughout the Oakridge Acres community, specifically on East Mile Road, North Mile Road, West Mile Road, Green Lane, and Oban Crescent;
- b) a road width of 7 meters BE IMPLEMENTED;

- c) parking BE PERMITTED on one side of the road, to alleviate any potential traffic congestion and concerns;
- d) the attached presentation from A. Rozentals, Environmental Service Engineer, BE RECEIVED;

It is recommended that 'No Parking Anytime' zones be implemented at the following locations to address part c) of the above resolution:

- West side of East Mile Road from Oban Crescent to Riverside Drive;
- West side of Glen Crescent from Green Lane to Oban Crescent; and
- South side of Oban Crescent from Pinetree Drive to Sherene Terrace.




Figure 5: East Mile Road, Glen Crescent, and Oban Crescent

An amendment is required to Schedule 2 (No Parking) and Schedule 6 (Limited Parking) for the above changes.

#### 3. Regulatory Signs

a) A traffic study at the intersection of Cranbrook Road and Tillman Road demonstrated that the intersection satisfied the warrant for an All-way stop. It is necessary to add new stop signs on Cranbrook Road.




Figure 6: Cranbrook Road at Tillman Road

- b) The Wickerson Hills subdivision road layout has been approved and construction of the subdivision is underway. It is recommended that the following traffic controls be implemented to control the safe and efficient movement of traffic in the subdivision:
  - i. Stop Signs
    - Black Rail Terrace at Tibet Butler Boulevard;
    - Brayford Avenue at Tibet Butler Boulevard; and
    - Brunson Way at Tibet Butler Boulevard.
  - ii. Yield Signs
    - Brunson Way at Brayford Avenue;
    - Ironwood Road at Tibet Butler Boulevard; and
    - Tibet Butler Boulevard at Ironwood Road




Figure 7: Black Rail Terrace at Tibet Butler Boulevard, Brayford Avenue at Tibet Butler Boulevard, Brunson Way at Brayford Avenue, Brunson Way at Tibet Butler Boulevard, Ironwood Road at Tibet Butler Boulevard at Ironwood Road

An amendment is required to Schedule 10 (Stop Signs), Schedule 11 (Yield Signs) Schedule 13 (Through Highways) for the above changes.

## 4. Pedestrian Crossover (PXO)

The rehabilitation of Blackrriars Bridge will include a PXO Type "C" located on Ridout Street N east of the bridge at 128 m north of Albert Street.

An amendment is required to Schedule 13.1 (Pedestrian Crossovers) for the above changes.



### 5. Speed Limits

It recommended that the speed limit be reduced to 40 km/h at the following locations as per the School Zone Speed Limit Policy approved by Council:

#### Aberdeen Public School

**Grey Street** 

Adelaide Street N to 100 m west of William Street

It should be noted that Hamilton Road is classified as an arterial road; therefore, the School Zone Speed Limit does not apply.




Figure 10: Aberdeen Public School

Whisperwood Avenue September Place to Summerdale Crescent (south intersection)




Figure 11: Byron Somerset Public School

## Beal, Central and Catholic Central Secondary Schools

Maitland Street Bathurst Street to Dufferin Avenue

Waterloo Street Queens Avenue to Wolfe Street

William Street Bathurst Street to Queens Avenue

It should be noted that King Street, Queens Avenue and York Street are classified as arterial roads. The London Plan identifies Dundas Street as a Civic Boulevard or Rapid Transit Boulevard, which will function similar to arterial roads. Based on the above, the School Zone Speed Limit does not apply to these streets.




Figure 12: Beal, Central and Catholic Central Secondary Schools




Figure 13: F.D. Roosevelt Public School
