BACKGROUND

The Tree Protection By-law C.P.-1515-228 contains a number of maps identifying Tree Protection Areas across the City. It has recently come to the Civic Administration's attention that Key Map D-16 is a duplicate of Key Map D-15 and the correct Key Map D-16 is not currently contained in the By-law. The <u>attached</u> proposed by-law (Appendix "A") will correct the mapping error.

By-law No. C.P.____

A by-law to amend the C.P.-1515-228 entitled "A by-law to regulate the Injuring and Destruction of Trees and to encourage preservation and planting of Trees throughout the City of London and to repeal By-law No. C.P.-1466-249 entitled "A by-law to prohibit and regulate the destruction or injuring of trees in the City of London", by deleting Key Map D-16 and by replacing it with a new Key Map D-16.

WHEREAS The Corporation of the City of London enacted By-law C.P.-1515-228 on August 30, 2016 to regulate the injuring and destruction of trees and to encourage preservation and planning of trees throughout the city in accordance with the authority provided by the *Municipal Act*, 2001, S.O. 2001, c.25, as amended;

AND WHEREAS the Municipal Council had determined it desirable to delete Key Map D-16 and replace it with a new Key Map D-16 to address a mapping error;

NOW THEREFORE the Council of The Corporation of the City of London hereby enacts as follows:

- 1. That By-law C.P.-1515-228 be amended by deleting Key Map D-16 and replacing with a new Key Map D-16 <u>attached</u> to this by-law as Schedule "A";
- 2. This by-law shall come into effect on the day it is passed.
