By-law No. C.P.-1363()-amend

A by-law to amend By-law. C.P.-1363-381 entitled, "A by-law to prohibit and regulate the placing or dumping of fill and the alteration of the grade of land in defined areas of the City of London."

COMMUNITY PLANNING

WHEREAS section 23.1 of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, provides that Municipal Council is authorized to delegate its powers and duties under this or any other Act to a person or body subject to any restrictions set out;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

1. Section 1.1 of By-law CP-1363-381, as amended, is hereby further amended by deleting the following definition:

"City Planner" shall mean the person who holds the position of City Planner for The Corporation of the City of London"

2. Section 1.1 of By-law CP-1363-381, as amended, is hereby further amended by deleting the following definition:

"Director of Development Planning" shall mean the person who holds the position of Director of Development Planning for The Corporation of the City of London"

3. Section 1.1 of By-law CP-1363-381, as amended, is hereby further amended by adding the following definition:

"Manager, Development Services and Engineering Liaison" shall mean the person who holds the position of Manager, Development Services and Engineering Liaison for The Corporation of the City of London."

4. Section 1.1 of By-law CP-1363-381, as amended, is hereby further amended by deleting the following definition:

"Managing Director of Development Approval Business Unit" shall mean the person who holds the position of Director of Development Approval Business Unit for The Corporation of the City of London"

5. Section 1.1 of By-law CP-1363-381, as amended, is hereby further amended by adding the following definition:

"Director, Development and Compliance" shall mean the person who holds the position of Director, of Development and compliance for The Corporation of the City of London."

6. Section 7-1 of By-law CP-1363-381, as amended, is repealed and replaced with the following:

7.1 Administration and enforcement of by-law – absence

The administration and enforcement of this bylaw shall be performed by the Director, Development and Compliance. When the Director, Development and Compliance is absent or his office is vacant then the Manager, Development Services Engineering Liaison shall act in the place and stead of the Director, Development and Compliance under this by-law and while so acting has and may exercise all the rights, powers and authority of the Director, Development and Compliance as delegated by this by-law subject to the same responsibilities and limitations set out in this by-law."

7. Section 7.6.2 of By-law CP-1363-381, as amended, is hereby further amended by deleting the term “of Planning and Development”

8. By-law No. CP-1363-381, as amended, is hereby further amended by deleting all references to the term “City Planner” and by replacing them with the term “Director, Development and Compliance”.

9. This by-law comes into force and effect on the date that it is passed.
