Subject: RE: Urgent request for Mayor Brown to sign Great Lakes Mayors joint sign on letter to Minister McKenna re: OPG proposed nuclear waste repository

Dear Mayor Brown and Members of Council,

The City of London unanimously passed a resolution at the October 1, 2013 council meeting opposing Ontario Power Generation's (OPG) plan to construct a nuclear waste repository about 1 km from the shore of Lake Huron in Kincardine Ontario at the Bruce Nuclear Generating Station site and to bury and abandon in the repository all of Ontario's low and intermediate radioactive nuclear waste.

Specifically, the City of London resolution passed on October 1, 2013 "resolved that the Municipal Council of the Corporation of the City of London, in order to protect the Great Lakes and its tributaries, urges that neither this proposed nuclear waste repository near Kincardine, Ontario, nor any other underground nuclear waste repository, be constructed in the Great Lakes Basin, Inc Canada, in the United States, or on any First Nations property."

Over the past 4 years our organization, Stop The Great Lakes Nuclear Dump, has undertaken an extensive outreach *effort* to encourage Great Lakes communities to pass resolutions opposing OPG's plan. Today, as a result of this very successful outreach *effort*, 224 resolutions representing over 23 million people opposing OPG's plan have been passed, including by the City of London. See

http://www.stopthegreatlakesnucleardump.com/resolutions.php for a list of resolutions passed to date. Note, London was one of the early communities in Ontario to recognize and take action to this threat to the drinking water of 40 million people to pass a resolution.

As noted in my original email to Mayor Brown in early May and subsequent communications (please see email trail below), working closely with Mayor Keith Hobbs (City of Thunder Bay) and Mayor Mike Bradley (City of Sarnia) our organization launched a new initiative encouraging Mayors of communities that have passed resolutions to sign an open letter to Minister McKenna. Our goal is to have at least 100 mayors sign the attached joint sign on letter and once this has been achieved, to send the letter to Minister McKenna.

When I originally contacted Mayor Brown, I was in the very early stages of approaching resolution community Mayors about the joint sign on letter. At the time I had secured signatures from 12 Mayors.

Fast forward to today, 7 weeks later; I am very pleased to report that Great Lakes Mayors (or top elected official) whose communities have passed resolutions opposing OPG's plan, have very enthusiastically signed onto the open letter to Minister McKenna. With 93 signatories in hand, we are very confident that we will soon meet or exceed our initial goal of 100 signatures on the open letter to Minister McKenna. FYI, signatories are from communities in Ontario, Michigan, Illinois, Indiana, Minnesota, Ohio and Wisconsin. The latest listing of 93 signatories is attached, for your information.

Mayor Brown and Council (with a copy to City Clerk Saunders), today I am writing to formally request that the City of London Council pass a resolution endorsing Mayor Brown's name being added to the attached open letter to Minister McKenna.

In considering this request, I would ask that you consider the following:

- You should know that citizens of London are very engaged and strongly opposed to OPG's plan to bury nuclear waste on the shores of Lake Huron:
 - Almost 2500 citizens from the City of London have signed the Stop The Great Lakes Nuclear Dump petition. After the City of Toronto, London is #2 in terms of the number of citizens signing our petition. Incidentally our petition is approaching 100,000 signatures. See https://www.gopetition.com/petitions/stopthegreatlakesnu-cleardump.html
 - 2. About 37°/o of Londoners who have signed our petition have taken the time to leave comments. Please see attached PDF which provides a selection of comments publicly displayed on our petition by citizens living in your community. Very clearly, the citizens of London feel very strongly that OPG's application to construct its proposed nuclear waste repository be rejected. Note: The name of the petitioner leaving the comment has not been provided for privacy reasons.
- The statement made in the open letter to Minister McKenna, namely "Signatories to this letter, all duly elected officials of Great Lakes communities that have passed resolutions, remain deeply opposed and united in opposition to the permanent burial of nuclear waste anywhere in the Great Lakes basin.." is consistent, aligned and supports the City of London resolution that opposed the construction of any nuclear waste repository anywhere in the Great Lakes basin.

Mayor Brown and Council, the open letter to Minister McKenna seeks to leverage the 224 individual resolutions passed by Great Lakes communities and provides a vehicle for these communities (including London) to stand shoulder to shoulder in expressing their opposition to OPG's plan. In our view, a document with 100 signatures from communities that have formally passed resolutions is a very potent document that can be used to increase media and public awareness and ramp up political pressure on the Canadian government to reject OPG's plan. In our view, the joint letter demonstrates that the interests of Great Lakes communities are aligned, and that these communities remain committed and united in their opposition to OPG's plan to bury nuclear waste beside North America's most precious resource. We believe this sends a powerful message to Minister McKenna and the Canadian government that will be difficult to ignore.

Given that a decision on this matter could occur in the summer of 2017, we feel it is very important and urgent that communities who obtain their drinking water from the Great Lakes, such as London, continue to apply political pressure on Minister McKenna to reject OPG's plan.

Mayor Brown and Council, as we approach the 100 signature mark, we are hoping you will, at your earliest opportunity, pass a resolution endorsing Mayor Brown's signature being added to the open letter to Minister McKenna.

Thank you for your consideration of this request.



A quick update:
