<b>RECOMMENDATION</b>

That on the recommendation of the Acting Director, Roads & Transportation, the attached proposed by-law (Appendix "A") **BE INTRODUCED** at the Municipal Council meeting to be held on September 19, 2011 for the purpose of amending the Traffic and Parking By-law (P.S. 111).

<b>BACKGROUND</b>
-------------------

The Traffic and Parking By-law (P.S.111) requires amendments (Appendix "A") to address traffic safety, operations and parking concerns. The following amendments are proposed:

Bathurst Street

Bathurst Street was recently reconstructed between Ridout Street and Wellington Street. On street parking has been relocated to newly built parking bays on the north side of the road. Amendments are required to Schedule 2 (No Parking), Schedule 6 (Limited Parking), Schedule 20 (2-hour Metered Parking) and Schedule 21.1 (10 hour Metered Parking).

Jalna Boulevard

Traffic calming measures were recently constructed on Jalna Boulevard between Bradley Avenue and Ashley Crescent (South Intersection). On-street parking in the vicinity of the measures should be restricted to ensure that no vehicles are parked in the narrowed street areas. An amendment is required to Schedule 2 (No Parking).

South Carriage Road

Municipal staff received complaints that parked vehicles on the inside of the curves on South Carriage Road make it difficult to see oncoming traffic. An amendment is required to Schedule 2 (No Parking) to address this safety concern.

Wonderland Road North

Bicycle lanes were recently introduced on Wonderland Road North between Gainsborough Road and Fanshawe Park Road West with a road widening project. An amendment is required to Schedule 9.1 (Reserved Lanes)

Typographical Errors

A review of the by-law found several typographical errors or sections that have been inadvertently deleted. Changes are required to address the following:

1. Parking on Elmgrove Crescent and Ensign Drive;
2. Prohibited turns on Cheapside Street at Gammage Street and on Commissioners Road West at Halls Mills Road; and
3. Heavy Truck Restrictions on Decker Drive and Wonderland Road South.





**BY-LAW TO AMEND THE TRAFFIC & PARKING BY-LAW (P.S. 111)**

Bill No.

By-law No. PS-111

A by-law to amend By-law PS-111 entitled, "A by-law to regulate traffic and the parking of motor vehicles in the City of London."

WHEREAS subsection 10(2) paragraph 7. of the *Municipal Act, 2001*, S.O. 2001, c.25, as amended, provides that a municipality may pass by-laws to provide any service or thing that the municipality considers necessary or desirable to the public;

AND WHEREAS subsection 5(3) of the *Municipal Act, 2001*, as amended, provides that a municipal power shall be exercised by by-law;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

**1. No Parking**

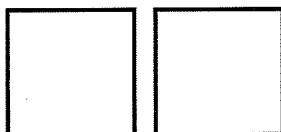
