RE: London Police Service Community Consultation Process

In 1999, the Ontario government passed Ontario Regulation 3/99, commonly referred to as the Adequacy Standards Regulation. The Regulation requires every police service in Ontario to develop a business plan, and to consult with members of the community to determine their level of satisfaction with policing as well as the direction that the service should be taking relative to the needs of the community. This consultation is to include our citizens, business persons, educators and politicians.

We want to ensure our business plan is reflective of what you, the people of London, want in terms of service and programs. We recognize that our strength stems from our partnership with all members of our community, and our success will be achieved through the co-operation and commitment of all of us. The consultation process is intended to be ongoing, with community input being a major contributor towards the development of the Business Plan.

As you know, organizations must listen to those individuals and groups who are the recipients of their service. Through our various partnerships we must be prepared to change in response to both reasonable criticism and positive suggestions for change. These partnerships shall continue and will, in fact, increase to accommodate community interests and needs where they can be reconciled with our mandate under the Police Services Act.


