RECOMMENDATION

BACKGROUND

In early 2017, the application process was launched for the annual Innovation & Capital grant stream of the London Community Grants Program.

The purpose of this report is to provide Council with the 2018 allocations for the Innovation & Capital stream of the London Community Grants Program. This report also provides additional information regarding the London Children's Museum request for capital funding should Council wish to consider their request as part of the 2018 annual budget update process.

1. London Community Grants Program Innovation & Capital Allocations for 2018

Through the 2016-2019 Multi-Year Budget process, Council approved the following funding for the Innovation & Capital stream:

A total of 33 applications, with requests totaling more than \$3.8M were received for 2018. Through the Community Review Panel's decision making process, a total of twelve projects, seven projects in the Innovation category, and five projects in the Capital category have been supported for funding.

From June 28th to July 13th the appeals process was conducted for the Innovation & Capital stream. Civic Administration received, reviewed, and addressed appeals as per the guidelines and timelines outlined in the London Community Grants Policy. As per the Policy, decisions on appeals are final. The complete list of organizations granted funding for 2018, along with a brief description of the specific projects funded is attached as Appendix 1.

2. London Children's Museum Capital Funding Request for 2018

The London Children's Museum submitted an application for 2018 capital funding in the amount of \$2M. This request was to contribute to an overall estimated capital cost of \$15.0M for the relocation of the Children's Museum to a new facility in 2018. The Community Review Panel reviewed this application based

on its merit and prioritized it to be funded. However, based on the amount requested and the available funding for the Innovation & Capital stream in 2018, the Panel referred this request to City Council for consideration noting that if additional funding was available, the Panel would be supportive of providing one-time capital funding to the London Children's Museum.

Should Council wish to consider the capital funding request from London Children's Museum, Civic Administration should be directed to work with the Children's Museum to prepare a Budget Amendment form for consideration as part of the 2018 Annual Budget Update. This would enable Council to assess the London Children's Museum funding request in relation to the other budget priorities.

Next Steps

From September to December 2017, Civic Administration will work with all funded organizations to sign grant agreements for funding to be released in early January 2018.

In 2018, Civic Administration will review the current London Community Grants Program policy in preparation for the next round of multi-year funding (2020 – 2024), and bring a revised policy to Council for endorsement in early 2019 prior to the call for applications. As part of this policy review, Civic Administration will consider a process for large one-time capital asks, noting that these requests currently fall outside the scope and budget allocated to the current Innovation & Capital stream.

FINANCIAL IMPACT

Annual funding to support the London Community Grants Program exists in the Neighbourhood, Children and Fire Services base budget, which was approved through the 2016-19 Multi-Year Budget process. The amount of funding allocated to the municipal granting program will be confirmed each year as part of the annual budget update process. Any adjustments to the funding allocated to the program will require Council approval through the annual budget update. Consistent with this approach, should Council wish to consider the \$2M capital funding request from London Children's Museum, Civic Administration should be directed to work with the Children's Museum to prepare a Budget Amendment form for consideration as part of the 2018 Annual Budget Update. This would enable Council to assess the London Children's Museum funding request in relation to the other budget priorities.

SUMMARY

As a City, we continue to focus on investments that enhance local capacity, support accessible, responsive programming, increase quality of life for all, and continue to make London a leader in commerce, culture and innovation – our regions connection to the World.
