## **NOTICE OF APPLICATION TO AMEND THE ZONING BY-LAW**

The Municipal Council for the City of London is considering an amendment to the City's Zoning By-law for the lands shown on the attached map. The requested change is described below. We are advising you of this application to invite your comments.

### **APPLICANT:**

Youth Opportunities Unlimited

### **LOCATION:**

329 and 331 Richmond Street - see attached map

### **PURPOSE AND EFFECT:**

The purpose and effect of this zoning change is to permit the re-use/redevelopment of the existing structure and allow for a 5 storey addition above the existing structures. This will result in a 6 storey building that will provide office space for Youth Opportunities Unlimited (YOU) on the first and second floors while permitting 36 apartment units on floors 3-6. The apartment will include a mix of one and two bedroom units.

### **POSSIBLE AMENDMENT:**

Change Zoning By-law Z.-1 from a Holding Downtown Area (h-3\*DA1\*D350) Zone to a Holding Downtown Area Bonus (h-3\*DA1\*D350\*B ( \_ )) Zone to permit the same range of uses which currently exists with a bonus zone to permit a residential density of 587uph in return for return for eligible facilities, services and matters outlined in Section 19.4.4 of the Official Plan. Other provisions such as parking and residential setbacks may also be considered through the re-zoning process as part of the bonus zone.

### **PLANNING POLICIES:**

Any change to the Zoning By-law must conform to the policies of the Official Plan, London's long-range planning document. These lands are currently designated as Downtown Area in the Official Plan, which permits a broad range of retail; service; office; institutional; entertainment; cultural; high density residential; transportation; recreational; and open space uses.

The subject lands are in the Downtown Place Type in *The London Plan* (Council-adopted but not in force and effect), permitting the same broad range of retail; service; office; institutional; entertainment; cultural; high density residential; transportation; recreational; and open space uses.

The written submissions, including names and contact information and the associated reports arising from the public participation process, will be made available to the public, including publishing on the City's website. Video recordings of the Public Participation Meeting may also be posted to the City of London's website. This application is considered to be residential intensification under the policies of the City's Official Plan. While a public site plan meeting is not required for this application, site plan matters, including those matters set out in the intensification policies of the Official Plan, will be considered as part of the staff review of this application. By way of this letter, we are also asking for your input and comments regarding this proposal. The matters that you might want to consider include fencing, landscaping, lighting, driveway locations, building scale and design, and the location of the building on the site. These policies are found in Section 3.2.3.5 of the Official Plan, and may be viewed online at the City of London Website, [www.london.ca](http://www.london.ca).

A neighbourhood or community association may exist in your area. If it reflects your views on this proposal, you may wish to select a representative of the association to submit comments on your behalf.

## **PUBLIC MEETING:**

The appropriateness of the requested Zoning By-law amendment will be considered at a future meeting of the Planning & Environment Committee. You will receive another notice inviting you to attend this meeting.

If a person or public body does not make oral or written submissions at a public meeting or make written submissions to the City of London before the proposed amendment is adopted, the person or public body may not be entitled to appeal the decision of the Council of the City of London to the Ontario Municipal Board, or may not be added by the Board as a party to the hearing of an appeal unless, in the opinion of the Board, there are reasonable grounds to do so.
