

 - ▶ Non-academic-sourced research projects imagined by community organizations
 - Available to institutional researchers
 - ▶ Encourage research partnerships initiated by non-academics
- Curated outcome webpages
 - ► Communicate research outcomes to wider audiences
- ► Currently in pilot development phase through Fall 2018
 - Heritage focus
 - ► High demand for expansion to other areas
- Western University administration and departments participating
 - ► Expanding to other universities shortly


The Research Portal How does it work?

- ▶ Develop a listing
 - ▶ Work with organizations to define
 - ► Scope
 - Timeframe
 - Desired outcomes
 - Available resources
 - ▶ Level of research (masters, doctoral, etc.)
 - ▶ Project liaison
 - Approve draft and post



The Research Portal How does it work?

- Review
 - Researchers review listings
 - ▶ Sort by location, discipline, researcher level
 - User-restricted
- Connect
 - ▶ Interested researchers contact liaison
 - Liaison chooses researcher
 - Researcher and organization outline research project
 - ▶ Define outcomes and methodologies
 - ▶ Formal research agreement



The Research Portal How does it work?

- Research
 - Managed by researcher and organization
 - ▶ Research Portal connects but cannot guarantee/manage activities
- Disseminate
 - ▶ Researcher and organization agree on outcome webpage content
 - ► Research Portal publishes webpage

Exterior view of 653 Talbot Street, January 1910, Construction








- existing building will be retained with very little change to the exterior
