- 2) The additional financing requirement of \$4,778,318 is available as a transfer from Capital Project RC2758 (South East Multi-Purpose Rec Centre-Arena Anchored) for a total of \$3,919,218 plus additional debenture of \$859,100 (serviced through City Services-Parks & Rec. Reserve Fund). An additional budget request would be required in 2020 to replace the funding shift to the East project (RC2756).
- 3) The anticipated annual cost of operating the East Community Centre facility (inclusive of staffing, utilities and maintenance), net of anticipated annual user fee revenues, is expected to be in the range of \$300,000 to \$400,000 per year, noting that this estimate is subject to further refinement. Civic Administration will follow the usual process to prepare a 2019 Assessment Growth Case to provide the necessary funding for the net operating costs
- 4) Development charges have been utilized in accordance with the underlying legislation and the Development Charges Background Studies completed in 2014.
