RECOMMENDATION

- b) the <u>attached</u> proposed by-law (Appendix B) **BE INTRODUCED** at the Municipal Council meeting to be held on October 17th, 2017 to amend By-law No. PH-4, Dog Licensing & Control to amend fees and charges related to dog registration licensing fees within Schedule "A" attached to the by-law, and minor housekeeping amendments; and
- c) the <u>attached</u> proposed by-law (Appendix C) **BE INTRODUCED** at the Municipal Council meeting to be held on October 17th, 2017 to amend By-law No. PH-5, Public Pound Bylaw to amend fees and charges related to dog registration licensing fees within Schedule "A" attached to the by-law; and minor housekeeping amendments; and
- d) the <u>attached</u> proposed by-law (Appendix D) **BE INTRODUCED** at the Municipal Council meeting to be held on October 17th, 2017 to amend By-law No. PH-12, Pit Bull Dog Licensing By-law to amend fees and charges related to dog registration licensing fees within Schedule "A" attached to the by-law.



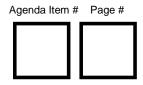
BACKGROUND

In September of 2014 Civic Administration reported to Community and Protective Services Committee on animal welfare strategies and with Council approval implemented a number of amendments to the Animal Control By-law PH-3 and Dog Licensing & Control By-law PH-4. At that time new fee structuring was implemented as well allowing some new fees that allowed discounts to cat and dog owners who had their animals both altered and microchipped, as well



as a discount offered to seniors. The only licensing fees that were increased at that time were for a complete/intact dog and cat. All other fees have not been increased since 2006.

Proposed current and proposed fees for each by-law as follows:









London Animal Care has never typically patrolled for cats at large but will impound confined cats delivered to the pound, in accordance with the wording of the agreement between the City of London and Urban Animal Management.

Bill No. 2017

By-law No.

A By-law to amend By-law PH-12 entitled, "A by-law to provide for the licensing and regulation of the keeping of Pit Bull Dogs in the City of London".

WHEREAS subsection 5(3) of the *Municipal Act*, 2001 S.O. 2001, c.25, as amended, provides that a municipal power shall be exercised by by-law;

AND WHEREAS section 9 of the *Municipal Act, 2001* provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

AND WHEREAS Part IV of the *Municipal Act, 2001* provides for a system of licences with respect to any activity, matter or thing for which a by-law may be passed, and "licence" is defined in the Act to include a permit, an approval, a registration and any other type of permission;

AND WHEREAS subsection 10(2) of the *Municipal Act, 2001* provides that a municipality may pass by-laws respecting "economic, social and environmental well-being of the municipality", "health, safety and well-being of persons", "protection of persons and property", and "animals";

NOW THEREFORE the Council of The Corporation of the City of London enacts as follows:


- 1. Schedule "A" of By-law PH-12 is deleted and replaced with a new Schedule "A", attached to this by-law as 'Schedule "A".
