#### **BACKGROUND**

#### **PURPOSE:**

This report provides the Waste Management Working Group (WMWG) with an update on Community Engagement Program activities for the Resource Recovery and Residual Waste Disposal Strategies that have taken place between June 6 and September 12, 2017.

#### **CONTEXT:**

In February 2017 Municipal Council directed City staff to undertake a number of actions with respect to the development of a long term Resource Recovery Strategy and a Residual Waste Disposal Strategy for the city of London. These actions included approving the general framework of the Community Engagement Program including:

- Using the following community engagement tools and forums: public notices, project website including use of the *getinvolved.london.ca website*, interested stakeholders contact and distribution list, open houses, meetings/presentations, City of London Advisory Committees, and using a range of information and communications tools; and,
- Contacting individuals and groups within the following broad stakeholder categories: the general public, the Government Review Team and Indigenous Communities.

The Community Engagement Program began on March 30, 2017 with the release of the Notice of Commencement.

The WMWG received its first update summary of community engagement activities on June 27, 2017 for the period March 30, 2017 to June 5, 2017.

#### Overview

A formal Public Consultation Report (i.e., the title assigned by the Ministry of Environment and Climate Change - MOECC) for the Residual Waste Disposal Strategy will be required as part of the EA process. This report will document all aspects of the Community Engagement Program including information on advertising, outreach, events and activities as well as comments received. A similar report will be prepared for the Resource Recovery Strategy by City staff. Below is a brief summary of the Community Engagement Program for the period June 6 to September 12, 2017. Complete details will ultimately be provided in the previously noted reports.

# On-line Feedback on Guiding Principles

There was limited input received on the Draft Guiding Principles (less than 20 participants). All Draft Guiding Principles received general support with the following principles receiving the most support:

- Make waste reduction the first priority;
- Be socially responsible; and,
- Ensure financial sustainability.

There were no Draft Guiding Principles that were added or ones that others felt should be deleted.

## **General Feedback**

Comments received online or at outreach events included:

- Support for a Green Bin program (majority of feedback (over 50%) received online and at outreach events)
- Many suggestions to increase diversion including reducing the container limit to one
  or two containers; increasing promotion; adding materials like plastic bags and
  expanded foam polystyrene to the Blue Box; providing free composters; increasing
  public space recycling; providing downtown recycling; supporting waste reduction
  with lending libraries, subsidize metal roofs, etc.;
- Landfill gas should be used as a source of electrical power generation as opposed to flaring;
- City should consider an Energy-from-Waste facility;
- Packaging producers should be more accountable for their waste; and,
- The City is moving too slow. It needs to catch up to other municipalities.

## **Next Steps for the Community Engagement Program**

The Community Engagement program will continue throughout the fall with a second series of open houses on November 29 and 30, 2017 focusing on the development of the Terms of Reference for the Environmental Assessment. Fall events currently include:

- Presentations to the Agricultural Advisory Committee on September 20;
- Individual stakeholder meetings (1 meeting to be scheduled);
- Waste Management Community Liaison Committee and W12A Landfill Public Liaison Committee meetings; and,
- Feedback opportunities on the project website.

The Fall Open Houses will present information and solicit feedback on:

- The proposed expansion alternatives for W12A Landfill. It is anticipated there will be three or four expansion alternatives;
- Evaluation criteria to determine the overall preferred alternative;
- Proposed work plans for the technical studies that will be completed to gather information necessary to assess the evaluation criteria; and,
- Update on the Resource Recovery Strategy.
