SUBJECT	AMENDMENT TO THE COUNCIL POLICY BY-LAW – REPLACEMENT OF SCHEDULE "E" - PUBLIC NOTICE POLICY

RECOMMENDATION

That, on the recommendation of the City Clerk, the <u>attached</u> proposed by-law BE INTRODUCED at the Municipal Council meeting to be held on October 3, 2017 for the purpose of repealing and replacing Schedule "E"- Public Notice Policy to By-law No. A.-6151-17, being "A by-law to establish policies for the sale and other disposition of land, hiring of employees, procurement of goods and services, public notice, accountability and transparency, and delegation of powers and duties, as required under section 270(1) of the *Municipal Act, 2001*", in order to make various changes to include notice for environmental assessment terms of reference, and to update the policy to reflect current practices, titles and Committee references.

PREVIOUS REPORTS PERTINENT TO THIS MATTER

None.

BACKGROUND

Recent efforts have been undertaken to update each Council Policy. The Public Notice Policy has a number of references to the Board of Control, which no longer exists. Further, Municipal Council, at its meeting held on December 6, 2016, resolved that "the Civic Administration BE DIRECTED to report back at a future meeting of the Civic Works Committee with a Council Policy regarding potential procedures to require the draft Terms of Reference related to an Environmental Assessment (EA) process to be posted on the City of London's website for a minimum of 30 days prior to the draft Terms of Reference being brought forward to Municipal Council for consideration and approval." While the direction was to report back to the Civic Works Committee on the EA Terms of Reference notice process, that change affects a policy generally overseen by the Corporate Services Committee and further, housekeeping changes that are not under the purview of the Civic Works Committee are also being recommended at this time.

The <u>attached</u> proposed by-law provides for amendments to the current Public Notice Policy to make various changes to include notice for EA terms of reference and to update the Policy to reflect current practices, titles and Committee references.

By-law No. A.-6151()-

A by-law to amend By-law No. A.-6151-17, being "A By-law to establish policies for the sale and other disposition of land, hiring of employees, procurement of goods and services, public notice, accountability and transparency, and delegation of powers and duties, as required under section 270(1) of the *Municipal Act, 2001*" in order to amend Schedule "E" — Public Notice Policy to include public notice requirements pertaining to environmental assessment terms of reference, as well as other general housekeeping amendments.

WHEREAS section 5(3) of the *Municipal Act, 2001* S.O. 2001, c.25, as amended, provides that a municipal power shall be exercised by by-law;

AND WHEREAS section 9 of the *Municipal Act, 2001* provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

AND WHEREAS section 270(1) of the *Municipal Act, 2001* requires that a municipality adopt and maintain policies with respect to the sale and other disposition of land; hiring of employees; procurement of goods and services; circumstances in which the municipality shall provide notice to the public and, if notice is to be provided, the form, manner and times notice shall be given; the manner in which the municipality will try to ensure that it is accountable to the public for its actions and the manner in which the municipality will try to ensure that its actions are transparent to the public; and, the delegation of its powers and duties;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

- 1. Appendix "A" to Schedule "E" of By-law No. A.-6151-17 is repealed and replaced by the <u>attached</u> new Appendix "A".
- 2. This by-law shall come into force and effect on the day it is passed.
