NOTICE OF APPLICATION TO AMEND THE ZONING BY-LAW

The Municipal Council for the City of London is considering an amendment to the City's Zoning By-law for the lands shown on the attached map. The requested change is described below. We are advising you of this application to invite your comments.

APPLICANT:

Thames Valley District School Board

LOCATION:

790-794 Quebec Street - see attached map

PURPOSE AND EFFECT:

The purpose and effect of the requested Zoning By-law amendment is to permit an extension of the schoolyard for the East Carling Public School.

POSSIBLE AMENDMENT:

Change Zoning By-law Z.-1 from a Residential R2 (R2-2) Zone which permits single-detached, semi-detached, duplex and converted dwellings, to a Neighbourhood Facility (NF) Zone which permits day care centres, places of worship and elementary schools.

PLANNING POLICIES:

Any change to the Zoning By-law must conform to the policies of the Official Plan, London's long-range planning document. These lands are currently designated as Low Density Residential in the Official Plan, which primarily permits a range of low-rise, low density residential uses. Some secondary uses such as non-residential community facilities that are normally associated with, and integral to a residential environment such as churches, day care centres, libraries, schools, community centres, parks and public recreation facilities are also permitted.

The subject lands are in the Neighbourhood place type in *The London Plan* (Council-adopted but not in force and effect), permitting a range of residential uses, including community facilities such as schools and places of worship in appropriate locations such as those along Neighbourhood Connectors (Quebec Street).

Please Note: Personal information collected and recorded at the Public Participation Meeting, or through written submissions on this subject, is collected under the authority of the Municipal Act, 2001, as amended, and the Planning Act, 1990 R.S.O. 1990, c.P.13 and will be used by Members of Council and City of London staff in their consideration of this matter. The written submissions, including names and contact information and the associated reports arising from the public participation process, will be made available to the public, including publishing on the City's website. Video recordings of the Public Participation Meeting may also be posted to the City of London's website. A neighbourhood or community association may exist in your area. If it reflects your views on this proposal, you may wish to select a representative of the association to submit comments on your behalf.

PUBLIC MEETING:

The appropriateness of the requested Zoning By-law amendment will be considered at a future meeting of the Planning & Environment Committee. You will receive another notice inviting you to attend this meeting.

If a person or public body does not make oral or written submissions at a public meeting or make written submissions to the City of London before the proposed amendment is adopted, the person or public body may not be entitled to appeal the decision of the Council of the City of London to the Ontario Municipal Board, or may not be added by the Board as a party to the hearing of an appeal unless, in the opinion of the Board, there are reasonable grounds to do so.

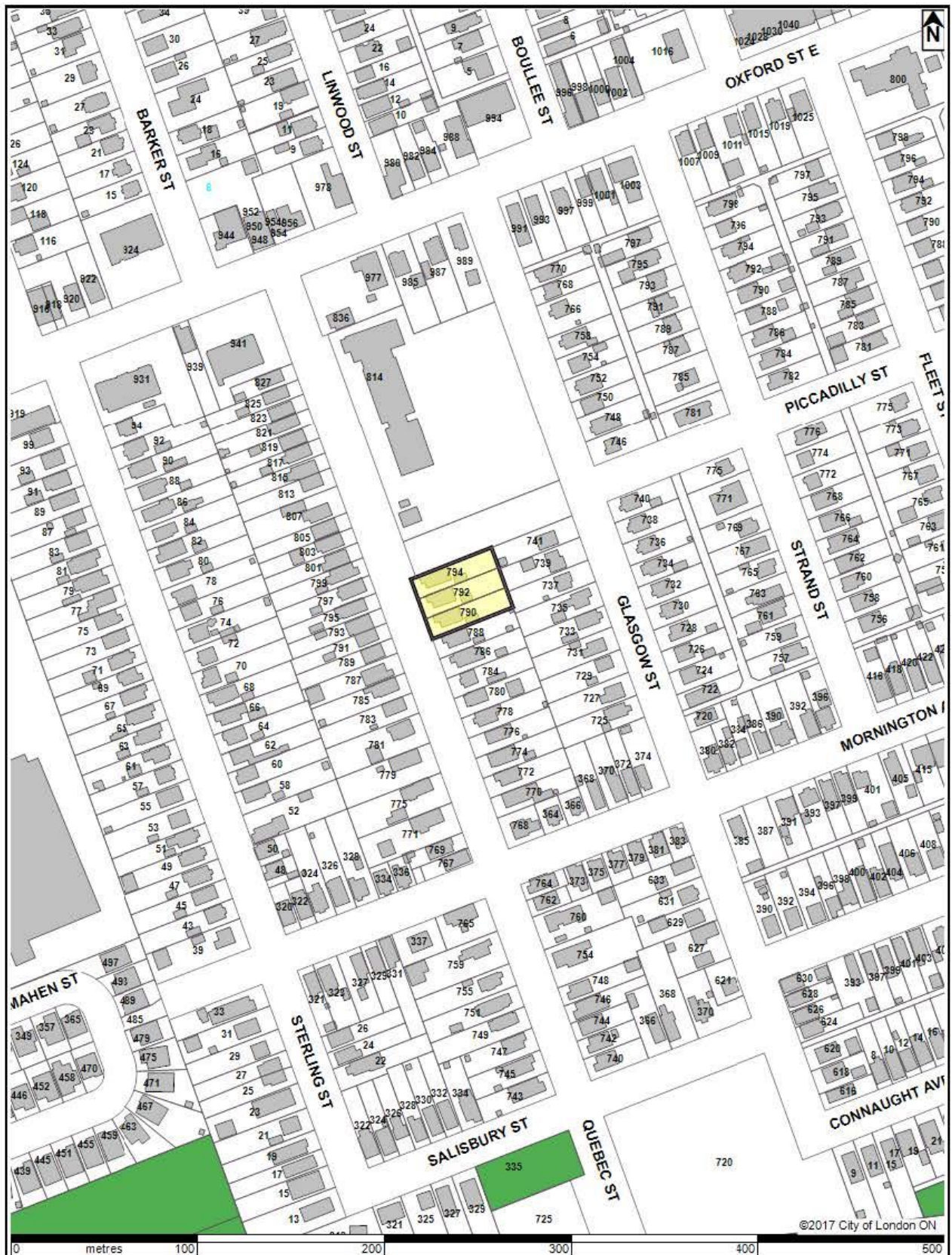

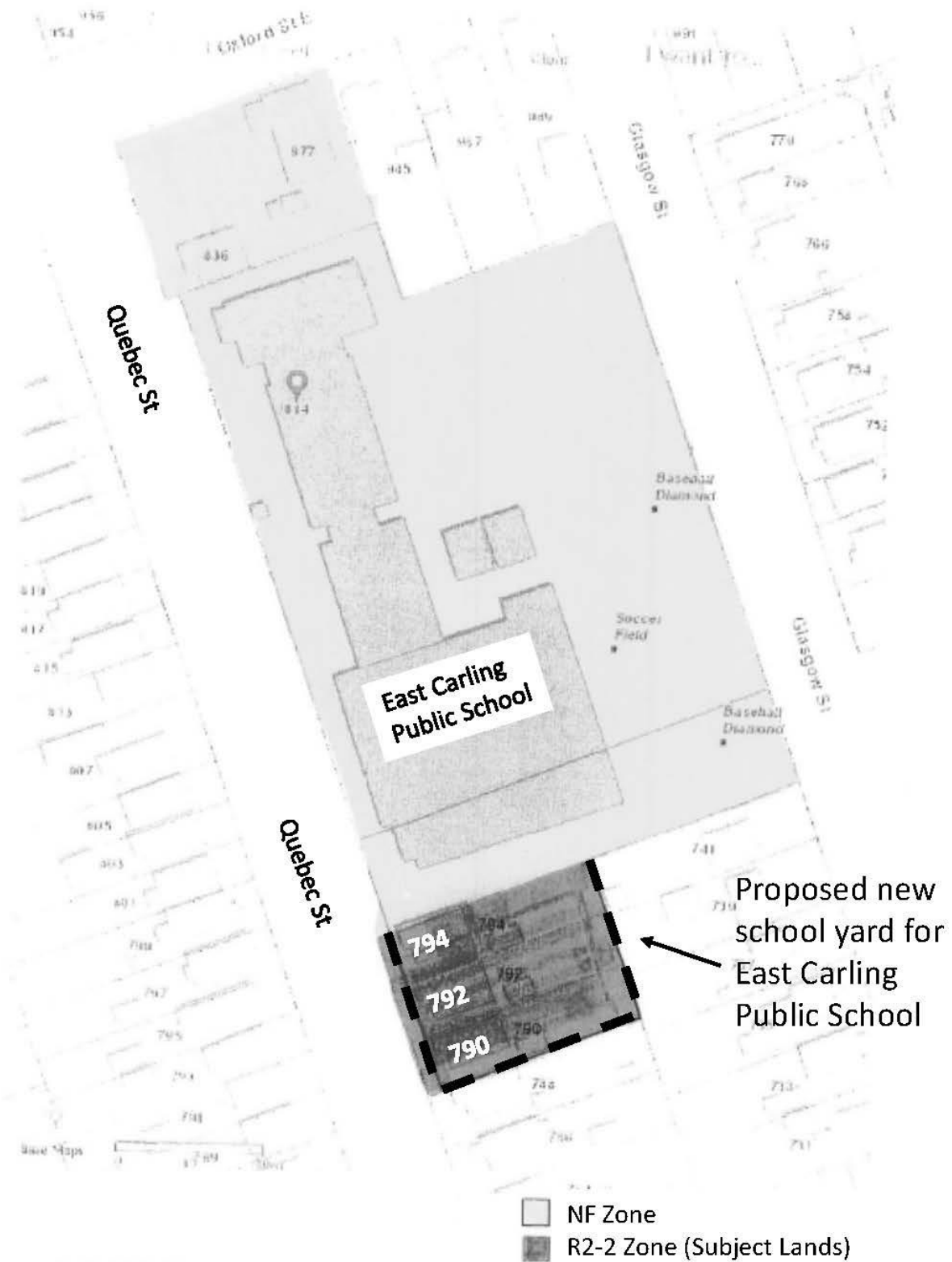
