SUBJECT:	AMENDMENTS TO THE TRAFFIC AND PARKING BY-LAW

#### RECOMMENDATION

That on the recommendation of the Managing Director, Environmental & Engineering Services and City Engineer, the <u>attached</u> proposed by-law (Appendix A) **BE INTRODUCED** at the Municipal Council meeting to be held on October 30, 2017 for the purpose of amending the Traffic and Parking By-law (PS-113).

#### 2015-19 STRATEGIC PLAN

The following report supports the Strategic Plan through the strategic focus area of **Strengthening Our Community** by improving safety, traffic operations and residential parking needs in London's neighbourhoods.

## **BACKGROUND**

The Traffic and Parking By-law (PS-113) requires amendments (Appendix A) to address traffic safety, operations and parking concerns. The following amendments are proposed:

## 1. No Stopping

Due to the construction of the cycle track on Colborne Street from Dufferin Avenue to Horton Street E, it is necessary to replace the existing time limited No Stopping zones, No Parking Anytime zones and the 2 Hour Metered Parking zones.




Figure 1: Colborne Street from Dufferin Avenue to Horton Street E

An amendment is required to Schedule 1 (No Stopping), Schedule 2 (No Parking), Schedule 9.1 (Reserved Lanes) and Schedule 20 (2 Hour Metered Zones) for the above changes.

## 2. No Parking

#### **Conway Drive**

At the request of local residents, a mail-back survey was sent to the impacted property owners on Conway Drive where the majority of the respondents supported implementing a 'No Parking Anytime' zone on the inside of the south curve of Conway Drive.




Figure 2: Conway Drive

# <u>Coronation Drive</u> (south of Gainsborough Road) and Lawson Road (south of Coronation Drive)

A review of the parking arrangements near St. John Catholic French Immersion Catholic School on Coronation Drive and Lawson Road identified inconsistencies between the signage and the by-law. Amendments are required to ensure the existing signage is reflected in Schedule 2 'No Parking' and to add 'No Parking Anytime' to Lawson Road.




Figure 3: Coronation Drive from South Carriage Road to Brunswick Avenue and Lawson Road south of Coronation Drive




Figure 4: Coronation Drive from Brunswick Avenue to Gainsborough Road

#### Third Street (CN Railway crossing to Oxford Street E)

Third Street from the CN Railway crossing to Oxford Street E was recently reconstructed including curb and gutter and a two-way left-turn lane as shown above. The new cross-section does not allow for on-street parking. It is recommended that the existing 'No Parking Anytime' zone on the west side of Third Street be extended to the CN Railway and the existing 'No Parking 3:00 a.m. to 5:00 a.m. be removed as it no longer applies.




Figure 6: Third Street from Oxford Street E to CN Rail Crossing

An amendment is required to Schedule 2 (No Parking) for the above changes.

## 3. Prohibited Turns

A new right-in/right-out driveway is being constructed on Crumlin Side Road north of Dundas Street. It is recommended to implement 'No U-Turns' for northbound and southbound traffic at either end of the centre median to address safety concerns.

An amendment is required to Schedule 8 (Prohibited Turns) for the above change.

## 4. Regulatory Signs

Due to operational and safety concerns, it is recommended to replace the existing Yield Sign with a Stop Sign on Thistleridge Crescent at Longworth road (north and south intersections) for eastbound drivers.




Figure 8: Thistleridge Crescent at Longworth Road

An amendment is required to Schedule 10 (Stop Signs) for the above change.

#### 5. Speed Limits

## Veterans Memorial Parkway (Wilton Grove Road to Highway 401)

Veterans Memorial Parkway is being extended southerly from Highway 401 to Wilton Grove Road along with the construction of a new interchange. It is recommended to reduce the existing 90 km/h posted speed limit to a 70 km/h maximum speed limit from the north limit of new interchange to Wilton Grove Road due to safety and operational requirements.




Figure 9: Veterans Memorial Parkway from north side of Highway 401 to Wilton Grove Road

#### Wonderland Road S (Wharncliffe Road S to Bradley Avenue W)

It is recommended that the posted speed limit on Wonderland Road S from Wharncliffe Road S to Bradley Avenue W be reduced from 70 km/h to 60 km/h to address safety and operational issues associated with the increased development. It should be noted that this change is consistent with Council's approved Speed Limit Policy.




Figure 10: Wonderland Road S from Exeter Road to Bradley Avenue W

An amendment is required to Schedule 17 (Higher Speeds) for the above changes.

## 6. School Zone Speed Limits

It recommended that the speed limit be reduced to 40 km/h at the following locations as per the School Zone Speed Limit Policy approved by Council:

## B. Davidson Secondary School and Lester B. Pearson School for the Arts

Trafalgar Street Lansdowne Avenue to Smith Street




Figure 11: B. Davidson Secondary School and Lester B. Pearson School for the Arts




Figure 12: Écolé élémentaire catholique Saint-Jean-de-Brébeuf




Figure 13: Écolé élémentaire Marie-Curie




Figure 14: Écolé secondaire Gabriel-Dumont




Figure 15: Evelyn Harrison Public School




Figure 16: London South Collegiate Institute & Tecumseh Public School




Figure 18: St. André Bessette Catholic Secondary School




Figure 21: St. John Catholic – French Immersion




Figure 22: St. Mark Catholic School & Northridge Public School




Figure 23: St. Thomas More Catholic School & Orchard Park Public School

### BY-LAW TO AMEND THE TRAFFIC & PARKING BY-LAW (PS-113)

Bill No.

By-law No. PS-113

A by-law to amend By-law PS-113 entitled, "A by-law to regulate traffic and the parking of motor vehicles in the City of London."

WHEREAS subsection 10(2) paragraph 7. Of the *Municipal Act, 2001*, S.O. 2001, c.25, as amended, provides that a municipality may pass by-laws to provide any service or thing that the municipality considers necessary or desirable to the public;
