NOTICE OF PUBLIC MEETING BEFORE THE PLANNING & ENVIRONMENT COMMITTEE for OFFICIAL PLAN AND DOWNTOWN COMMUNITY IMPROVEMENT PLAN AMENDMENT APPLICATIONS

APPLICANT:

The Corporation of the City of London

LOCATION:

A portion of the Downtown Business Improvement Area with properties fronting on Richmond Street between Dufferin Avenue and Sydenham Street. Please see attached map for more details.

PURPOSE AND EFFECT:

The purpose and effect of the requested Official Plan amendment is to amend the boundary of the Downtown Community Improvement Plan to include the Richmond Row area. Expansion of the Downtown CIP boundary (CIP project area) is being considered so that the City may provide financial incentive programs to properties within an expanded CIP Area. This action would implement Council's recent citywide review of financial incentives to support community improvement to provide Façade Improvement Loans and Upgrade to Building Code Loans in the Richmond Row area effective January 1, 2018.

POSSIBLE AMENDMENT:

A number of amendments are required to facilitate a change to the Downtown Community Improvement Plan Boundary, including:

1. **Amendment of the Downtown Community Improvement Plan** text to expand the Downtown CIP project area to include the Richmond Row area, and to *Figure 1 – The Downtown Community Improvement Area* to show the (new project area) boundary.
2. **Official Plan Amendment (1989 Plan)** to Section 14.2.2 ii) to include reference to Richmond Row, and to *Figure 14.1 – Areas Eligible for Community Improvement* to show the new boundary of the Downtown CIP area; and
3. **Official Plan Amendment (London Plan)** to *Map 8 – Community Improvement Project Areas* to show the new boundary of the Downtown CIP area.

Please note that changes to Chapter 14 - "Community Improvement Plans" of the 1989 Official Plan and Community Improvement Plan Policies of the "Our Tools" Chapter of the London Plan are proposed pursuant to Section 28 of the Planning Act, through which the City can provide financial incentives to property owners.

PUBLIC MEETING:

By letter dated July 12, 2017, you were informed of the possible amendment described above.

You are now advised that the Planning & Environment Committee will consider this application at its meeting on **Monday, November 6, 2017 no earlier than 4:00 p.m.** Meetings are held in the Council Chambers of City Hall, located at 300 Dufferin Avenue (north-east corner of Wellington Street). Each application is allocated a time for public delegations. It should be recognized however, that the Planning & Environment Committee may find it necessary to exceed the limit. Your co-operation is appreciated in the event that you have to wait for your application to be considered.

Please Note: Personal information collected and recorded at the Public Participation Meeting, or through written submissions on this subject, is collected under the authority of the Municipal Act, 2001, as amended, and the Planning Act, 1990 R.S.O. 1990, c.P.13 and will be used by Members of Council and City of London staff in their consideration of this matter. The written submissions, including names and contact information and the associated reports arising from the public participation process, will be made available to the public, including publishing on the City's website. Video recordings of the Public Participation Meeting may also be posted to the City of London's website. If a person or public body does not make oral or written submissions at a public meeting or make written submissions to the City of London before the proposed amendment is adopted, the person or public body may not be entitled to appeal the decision of the Council of the City of London to the Ontario Municipal Board, or may not be added by the Board as a party to the hearing of an appeal unless, in the opinion of the Board, there are reasonable grounds to do so.

A neighbourhood or community association may exist in your area. If it reflects your views on this proposal, you may wish to select a representative of the association to submit comments on your behalf.

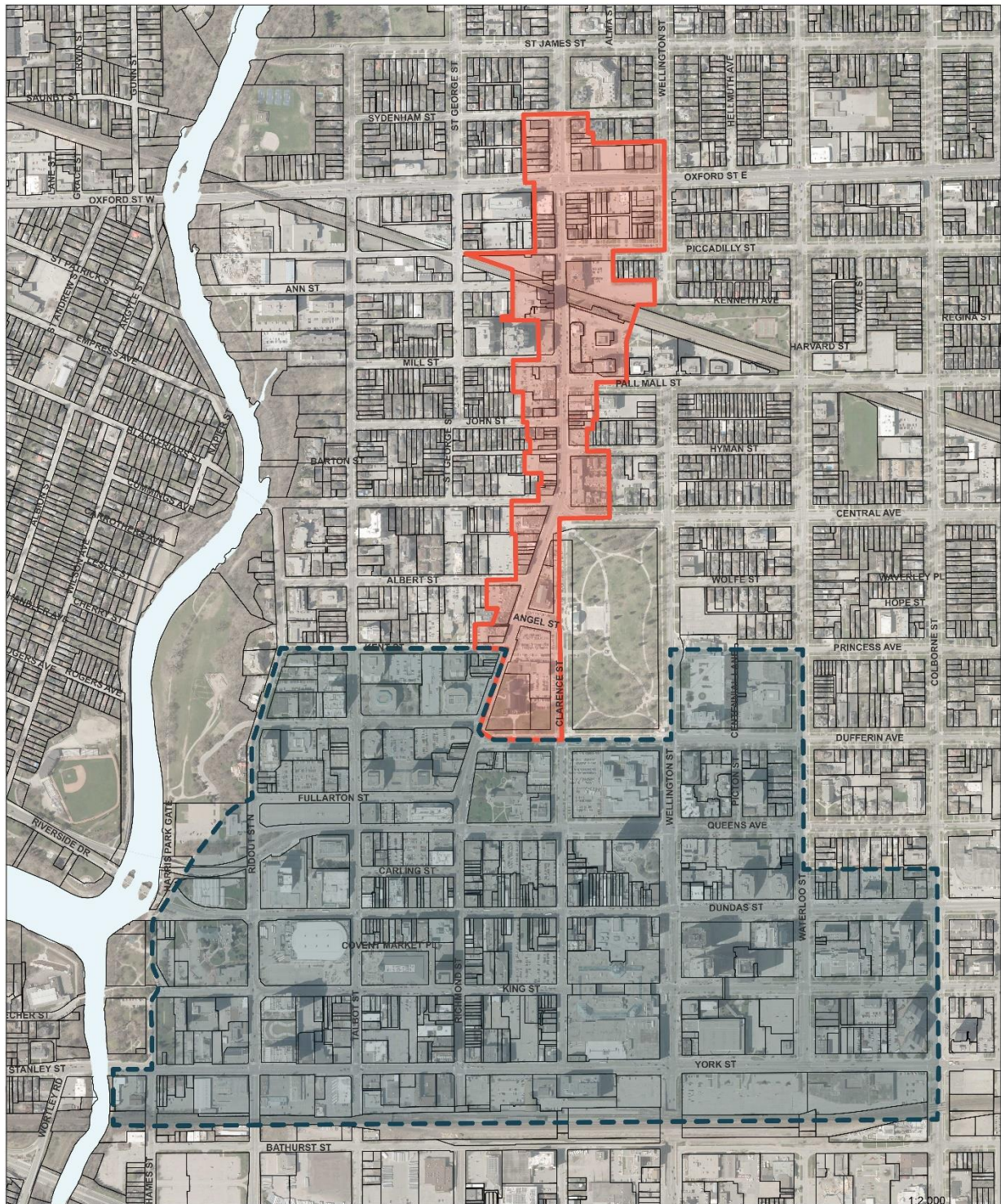
