By-law No. C .-

A by-law to establish the Water Customer Assistance Reserve Fund

WHEREAS section 9 of the *Municipal Act, 2001* as amended provides that a municipality has all of the rights, powers and privileges of a natural person;

AND WHEREAS subsection 10(1) of the *Municipal Act, 2001* as amended provides that a municipality may provide any service or thing that the municipality considers necessary or desirable for the public;

AND WHEREAS subsection 10(2) of the *Municipal Act, 2001* as amended provides that a municipality may pass by-laws respecting the financial management of the municipality (paragraph 3) and services or things that the municipality is authorized to provide under subsection10(1) (paragraph 7);

AND WHEREAS it is desirable to establish a reserve fund to provide for a source of funding for the Crisis Support, Crisis Prevention and Customer Assistance programs, as part of the of the new "value based" funding model for water and wastewater approved by Council December 11, 2012;

AND WHEREAS the Council considers the establishment of such Water Customer Assistance Reserve Fund necessary and desirable for the public;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

- 1. A reserve fund is hereby established to be known as the Water Customer Assistance Reserve Fund (hereinafter called the "Fund").
- 2. The monies standing in the Fund shall be used by The Corporation of the City of London (the "Corporation") for:
 - a) Funding approved under the Crisis Support Program
 - b) Funding approved under the Crisis Prevention Program
 - c) Funding approved under the Customer Assistance Program
- 3. The City Treasurer shall deposit into the Fund all funds allocated by Council for the purpose of supporting customer assistance outlined in the new value based funding model for water and wastewater .
- 4. Any subsequent monies raised through the annual water rates to be used as a contribution to the Fund shall be deposited to the Fund by the City Treasurer.
- 5. The City Treasurer or designate is authorized to allocate funds from the Water Customer Assistance Reserve Fund.
- 6. The City Treasurer may invest the monies standing in the Fund in such securities as are permitted under subsection 418(1) of the *Municipal Act, 2001* and in so doing, may consolidate the monies standing in the Fund with other funds that the Corporation may hold from time to time provided that any earnings derived from the monies standing in the Fund shall accrue to and form part of the Fund.
- 7. Notwithstanding that provision may not be made by the Council in the estimates of the current or any subsequent year for contributions to the Fund, it shall continue and be maintained, and the Council shall always be taken as considering the Fund as necessary so long as this by-law continues in force.

8. This by-law comes into force on the day it is passed.
