SUBJECT	AMENDMENTS TO THE TRAFFIC AND PARKING BY-LAW

RECOMMENDATION

That on the recommendation of the Managing Director, Environmental & Engineering Services and City Engineer the following actions **BE TAKEN**:


- a) the <u>attached</u> proposed by-law (Appendix "A") **BE INTRODUCED** at the Municipal Council meeting to be held on June 11, 2013 for the purpose of amending the Traffic and Parking By-law (P.S. 111); and
- b) the <u>attached</u> proposed by-law (Appendix "B") **BE INTRODUCED** at the Municipal Council meeting to be held on June 11, 2013 for the purpose of amending the Traffic and Parking By-law (P.S. 111) with respect to temporary changes on Bruce Street effective September 20, 2013.

BACKGROUND

The Traffic and Parking By-law (P.S.111) requires amendments (Appendix "A") to address traffic safety, operations and parking concerns. The following amendments are proposed:

1. No Stopping, No Parking, Loading Zones

- a) Parking bays and curb extensions were constructed on Blackacres Boulevard as the subdivision's traffic calming plan. On-street parking should be restricted at the end and on the opposed side of parking bays to insure that there are no vehicles in the narrow street area. An amendment is required to Schedule 2 (No Parking).
- b) City staff received complaints regarding lack of designated loading spaces on the north side of Dundas Street between Wellington Street and Waterloo Street. It is proposed to designate a single space loading zone in the middle of that section. An amendment is required to Schedule 5 (Loading Zones).
- c) In consultation with the Covent Garden Market, the existing 24 Hour Loading zone on the north side of King Street from 62 m east of Talbot Street to 30 m west of Covenant Market Place can be revised to will allow on-street parking after 6:00 pm for part of the existing 24 hr loading zone. It is proposed to designate an 8:00 am 6:00 pm Monday-Saturday Loading Zone from 62 m east of Talbot Street to 37 m west of Covent Market Place, and maintain 24 Hour Loading zone from 37 m to 30 m west of Covent Market Place. An amendment is required to Schedule 5 (Loading Zones).
- d) Due to safety concerns with vehicles parking within the curve on Portsmouth Road, it is proposed to create a No Parking Anytime zones on the inside of the curve. Concerns have been expressed that if vehicles are parked on the inside of the curve the visibility is greatly reduced. An amendment is required to Schedule 2 (No Parking).
- e) A mail-back survey was conducted on Thiel Street between Saskatoon Street and Borden Street to determine if the homeowners supported the removal of overnight No Parking restriction during summer months. The results of the mail-back survey indicated that the majority of respondents supported the parking regulations change. An amendment is required to Schedule 2 (No Parking).



- f) Parking bays and curb extensions were constructed on Tokala Trail as a part of subdivision requirements to address traffic calming. On-street parking should be restricted at the end and on the opposed side of parking bays to insure that there are no vehicles in the narrow street area. It is also necessary to designate No Parking Anytime zone on the same side and No Stropping 8:00 am 9:00 am and 2:00 pm 4:00 pm, Monday-Friday, September 1st June 30 zone on the opposite side of new Catholic Secondary School. Amendments are required to Schedule 1 (No Stopping) Schedule 2 (No Parking).
- g) Due to pedestrian safety concerns on Shaftesbury Avenue in front of Arthur Stringer Public School, it is proposed to create a No Stopping 8:00 am 9:00 am and 2:00 pm 4:00 pm, Monday to Friday, September to June zone on the north side of Shaftesbury Avenue along the school's property. Concerns have been expressed that students are crossing the road in places other than at a pedestrian crosswalk after being dropped off or for pick-up. An amendment is required to Schedule 1 (No Stopping).
- h) Due to pedestrian safety concerns on Tweedsmuir Avenue in front of Tweedsmuir Public School, it is proposed to create a No Stopping 8:00 am 9:00 am and 2:00 pm 4:00 pm, Monday to Friday, September to June zone on the north side of Tweedsmuir Avenue along the school's property. Concerns have been expressed that students are crossing the road in places other than at a pedestrian crosswalk after being dropped off or for pick-up. An amendment is required to Schedule 1 (No Stopping).
- i) Parking regulations on Brunswick Avenue between Coronation Drive and Elson Road were recently changed to address safety and roadway operation concerns. The residents on this section of road requested that the 'no parking' zone be re-examined which has been done. There are still roadway safety and operation concerns; however, one parking stall on the south side of Brunswick Avenue may be created to help mitigate the resident's concerns. An amendment is required to Schedule 2 (No Parking).


2. Regulatory Signs

- a) New stop signs are required to address right-of-way control in a new subdivision at the following intersections:
 - Howlett Circle at Stackhouse Avenue
- b) New yield signs are required to address right-of-way control in a new subdivision at the following intersections:
 - Couldridge Way at Wateroak Drive
 - Couldridge Way at Tokala Trail
 - Foxbend Link at Couldridge Way
 - Foxbend Link at Wateroak Drive
 - Brown Drive at Wateroak Drive
 - Brown Drive at Tokala Trail
 - Tokala Trail at Wateroak Drive
 - Aldersbrook Gate at Tokala Trail
 - Wateroak Drive at Tokala Trail

Amendments are required to Schedule 10 (Stop Sign Locations) and Schedule 11 (Yield Sign Locations)

3. One-way streets

- a) Albert Street is currently designated as one-way street between Talbot Street and Ridout Street North. It is necessary to convert this section to a two-way street from May 10th to October 1st, 2013 to allow for traffic access during the construction on Ridout Street North and the closure of Blackfriars Bridge. Amendments are required to schedule 2 (No Parking), Schedule 6 (Limited Parking) and Schedule 12 (One-way streets).
- b) Bruce Street is currently designated as one-way street From Wharncliffe Road South to Wortley Road. It is necessary to convert the section of Brice Street from Cynthia Street to Teresa Street to a two-way street from September 20th to November 1st, 2013 to allow for traffic access during the construction on Edward Street. Amendments are required to schedule 2 (No Parking) and Schedule 12 (One-way streets).



4. Metered Municipal and Public Parking Lots

a) It is necessary to include a parking lot at 78 Riverside Drive at Kiwanis Seniors Centre to the list of Metered Municipal and Public Parking Lots. Amendments are required to Schedule 22 (Metered Off-street Municipal Parking Lots) and Schedule 30 (Metered Municipal and Public Parking Lots).

5. <u>Unmetered Off-street Municipal Parking</u>

a) The City's Parking Enforcement Office has requested a by-law amendment to Part 3 Unmetered Off-Street Municipal Parking, Maximum Permitted Parking - Section 61 to replace "No person shall permit any motor vehicle to be parked or to remain parked" with "No person shall **park** any motor vehicle".

6. Typographical Errors

a) A review of the "No Parking" section of the by-law revealed deleted sections on the west side of Glenwood Avenue from Trafalgar Street to a point 45 m southerly and on the east side from Hamilton Road to a point 25 m north of Flora Street. An amendment is required to Schedule 2 (No Parking)



APPENDIX "A" BY-LAW TO AMEND THE TRAFFIC & PARKING BY-LAW (P.S. 111)

By-law No. PS-111

A by-law to amend By-law PS-111 entitled, "A by-law to regulate traffic and the parking of motor vehicles in the City of London."

WHEREAS subsection 10(2) paragraph 7. of the *Municipal Act, 2001*, S.O. 2001, c.25, as amended, provides that a municipality may pass by-laws to provide any service or thing that the municipality considers necessary or desirable to the public;

AND WHEREAS subsection 5(3) of the *Municipal Act*, 2001, as amended, provides that a municipal power shall be exercised by by-law;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

1. No Stopping

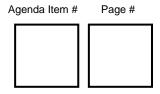





During the hours on the days mentioned in section 60, no person shall permit any motor vehicle to be parked or to remain parked on any of the parking lots mentioned in section 58 for a period which at any time exceeds the maximum limit for the particular parking lot in Column 4 of section 60.

And by **adding** the following text:


During the hours on the days mentioned in section 60, no person shall park any motor vehicle on any of the parking lots mentioned in section 58 for a period which at any time exceeds the maximum limit for the particular parking lot in Column 4 of section 60.




