THE LAKE HURON PRIMARY WATER SUPPLY SYSTEM JOINT BOARD OF MANAGEMENT

All Water Use Restrictions Lifted at 6:00p.m

Water use restrictions imposed as a result of the pipeline failure which occurred early Wednesday morning are lifted for all municipalities supplied by the Lake Huron Primary Water Supply System, including the City of London, at 6:00p.m. Saturday May 26th. All area storage reservoirs have been replenished to near normal operating conditions.

Although water use restrictions which were imposed as a result of the recent pipeline failure have ended, the Lake Huron Primary Water Supply System continues to encourage all consumers to conserve and use water wisely in their homes and businesses on a daily basis.

Background

In the coming weeks, the Lake Huron Primary Water Supply System will continue to investigate the cause of the May 23rd pipeline failure, the condition of the pipelines, as well as work with impacted landowners to repair the farmlands affected by the rupture and compensate for crop damages and losses.

 Approximately 500,000 consumers supplied by the Lake Huron & Elgin Area water system, reducing consumption to ensure adequate water supply during this incident. Approved in the 2012 Capital Budget, the Lake Huron Primary Water Supply will begin construction of additional twinning of the transmission pipeline in the Shipka and Ailsa Craig areas, which will provide additional pipeline pressure relief and security of supply to the region.

Also approved in the 2012 Capital Budget, the water system will undertake a comprehensive condition assessment of the original transmission pipeline constructed in the mid-1960's between the water treatment plant near Grand Bend in South Huron, and the terminal reservoir near Arva in the municipality of Middlesex Centre.
