Trees and Forests Advisory Committee

"The role of an advisory committee is to provide recommendations, advice and information to Municipal Council on those specialized matters which relate to the purpose of the advisory committee." Municipal Council Policy Manual, Chapter 5 Council and Committees

The terms of reference for the newly-created Trees and Forests Advisory Committee allowed for 11 voting members to be appointed in 2006.

3 members-at-large: B. Gilmore, P. Berton, C. Benson

1 representative from each of the following:

Local business association; J. Kennedy - London Development Institute Urban League of London: G. Sinclair
An active community planting group: J. Ryan - Reforest London
University of Western Ontario: J. Galbraith
Fanshawe College: 2 appointments - now vacant
London Community Foundation: withdrawn after 3 appointments
Environmental & Ecological Planning Advisory Committee: D. Sheppard
Advisory Committee on the Environment: 3 appointments - now vacant
City Council also appointed Councillor J. Baechler a voting member

The committee met for the first time on November 10, 2006. By April 2009, the London Community Foundation was replaced by the Middlesex-London Health Unit with J. Reffle, subsequently with I. Kalsi, and an additional 2 members, B. Shiell and G. Fournie, were appointed members-at-large.

The duties of the committee were to provide input, advice and make recommendations regarding the formation and implementation of London's Urban Forest Strategy through three main areas: planning and protection; planting and renewal; and, management and maintenance.

Over time, with the organizational changes implemented by Council, this committee has submitted its 51 meeting reports to date, containing recommendations related to its duties, to various Council committees: Environment and Transportation Committee, Built and Natural Environment Committee, Community and Neighbourhoods Committee and now the Planning and Environment Committee. Also, due to these changes the original 2-year appointment of the members has been extended to the current year 2012.

The initial activity of the committee was to review the related-work being done by City departments and other agencies, such as London Hydro. The committee established two subcommittees to identify tacts that could be taken to achieve an urban forest strategy - the Save More subcommittee and the Plant More subcommittee. The ideas from this work allowed the committee to begin to focus on the elements needed for a new strategy.

In the ensuing time, the committee has been instrumental in encouraging the Council to undertake: emergency tree watering guidelines, emerald ash borer management strategy, new street tree guidelines that reduced wait-times for boulevard tree replacement, improved annual reporting on tree removal and replacement, the urban forest effects (UFORE) project to identify and

quantify the London forest and to hire new personnel to facilitate related programs and to direct the creation of the new urban forest strategy using out-sourcing contracts.

In order to develop a better perspective of the city, the committee conducted three field tours to examine the work being done within the city to preserve and maintain trees and to establish trees in new developments by touring the centre of the city, development in the north part of the city and the management of the city's largest forest within Western University.

The committee has also sent letters of acknowledgment to citizens of the city recognizing individual efforts to support the direction of City interests.

By 2010 the committee developed a glossary of terms and a deferred list of its recommendations that were adopted by Council with a status update attached for the achievement of each recommendation.

The committee will continue to assist Council in the release of the final UFORE report and in the development of the new urban forest strategy with the contractor, as well as many other outstanding items such as the approved tree species list for the city, the tree conservation by-law and enforcement, and suitable staffing and funding to support ongoing activities.
