A by-law to amend By-law No. PS-113, entitled, "A by-law to regulate traffic and the parking of motor vehicles in the City of London."

WHEREAS subsection 10(2) paragraph 7. of the Municipal Act, 2001, S.O. 2001, c. 25 , as amended, provides that a municipality may pass by-laws to provide any service or thing that the municipality considers necessary or desirable to the public;
