RE: Monthly Report for October 2017

Attached are the Building Division's monthly report for October 2017 and copies of the Summary of the Inspectors' Workload reports.

Permit Issuance

By the end of October, 4,314 permits had been issued with a construction value of approximately \$1 billion, representing 2,249 new dwelling units. Compared to last year, this represents a 5% increase in the number of permits, a 12.7% decrease in the construction value and a 4.1% decrease in the number of dwelling units.

To the end of October, the number of single and semi-detached dwellings issued was 894, which was a 19% increase over last year.

At the end of October, there were 718 applications in process, representing approximately \$270 million in construction value and an additional 668 dwelling units, compared with 537 applications having a construction value of \$280 million and an additional 732 dwelling units for the same period last year.

The rate of incoming applications for the month of October averaged out to 20.6 applications a day for a total of 433 in 21 working days. There were 72 permit applications to build 72 new single detached dwellings, 13 townhouse applications to build 23 units, of which 10 were cluster single dwelling units.

There were 426 permits issued in October totalling \$81.2 million including 144 new dwelling units.

Inspections

BUILDING

Building Inspectors received 3,091 inspection requests and conducted 3,657 building related inspections. An additional 3 inspections were completed relating to complaints, business licenses, orders and miscellaneous inspections. Based on a staff compliment of 11 inspectors, an average of 305 inspections were conducted this month per inspector.

Based on the 3,091 requested inspections for the month, 86% were achieved within the provincially mandated 48 hour time allowance.

PLUMBING

Plumbing Inspectors received 1,388 inspection requests and conducted 1,689 plumbing related inspections. No inspections were completed relating to complaints, business licenses, orders and miscellaneous inspections. Based on a staff compliment of 6 inspectors, an average of 282 inspections were conducted this month per inspector.

Based on the 1,388 requested inspections for the month, 98% were achieved within the provincially mandated 48 hour time allowance.

NOTE:

In some cases, several inspections will be conducted on a project where one call for a specific individual inspection has been made. One call could result in multiple inspections being conducted and reported.


