SUBJECT:	BUSINESS LICENSING BY-LAW – TECHNICAL MAP CLARIFICATIONS

RECOMMENDATION

That, on the recommendation of the Managing Director, Development & Compliance Services and Chief Building Official, the technical mapping amendment (attached) to the Business Licensing By-law L -131-16 adopted by Council on December 12, 2017 **BE INTRODUCED** at the Municipal Council meeting of January 30, 2018 it being noted that this technical amendment provides for updated map schedules.

BACKGROUND

On December 12, 2017, Municipal Council approved a new Business Licensing By-law. The By-law comes into force and effect on April 3, 2018. The draft by-law presented at the October 4, 2017 omnibus public participation meeting included new updated map schedules outlining locations of adult live entertainment parlours and adult entertainment body-rub parlours. The version of the by-law passed by Council did not contain the new updated maps. The purpose of this technical amendment is to include the new maps.

A by-law to amend By-law No. L.-131-16 entitled
“A by-law to provide for the Licensing and
Regulation of Various Businesses”.

AND WHEREAS section 5(3) of the *Municipal Act, 2001* S.O. 2001, c.25, as amended, provides that a municipal power shall be exercised by by-law;

AND WHEREAS section 23.2 of the *Municipal Act, 2001* permits a municipality to delegate certain legislative and quasi-judicial powers;

AND WHEREAS it is deemed expedient to amend By-law No. L.-131-16, entitled “A by-law to provide for the Licensing and Regulation of Various Businesses”, passed on December 12, 2017;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

1. The Business Licensing By-law L.-131-16 is hereby amended by deleting Schedule 2A in its entirety and replacing it with the attached “Schedule 2A” maps.
2. The Business Licensing By-law L.-131-16 is hereby amended by deleting Schedule 3A in its entirety and replacing it with the attached “Schedule 3A” maps.
3. This by-law shall come into force and effect on the day it is passed.

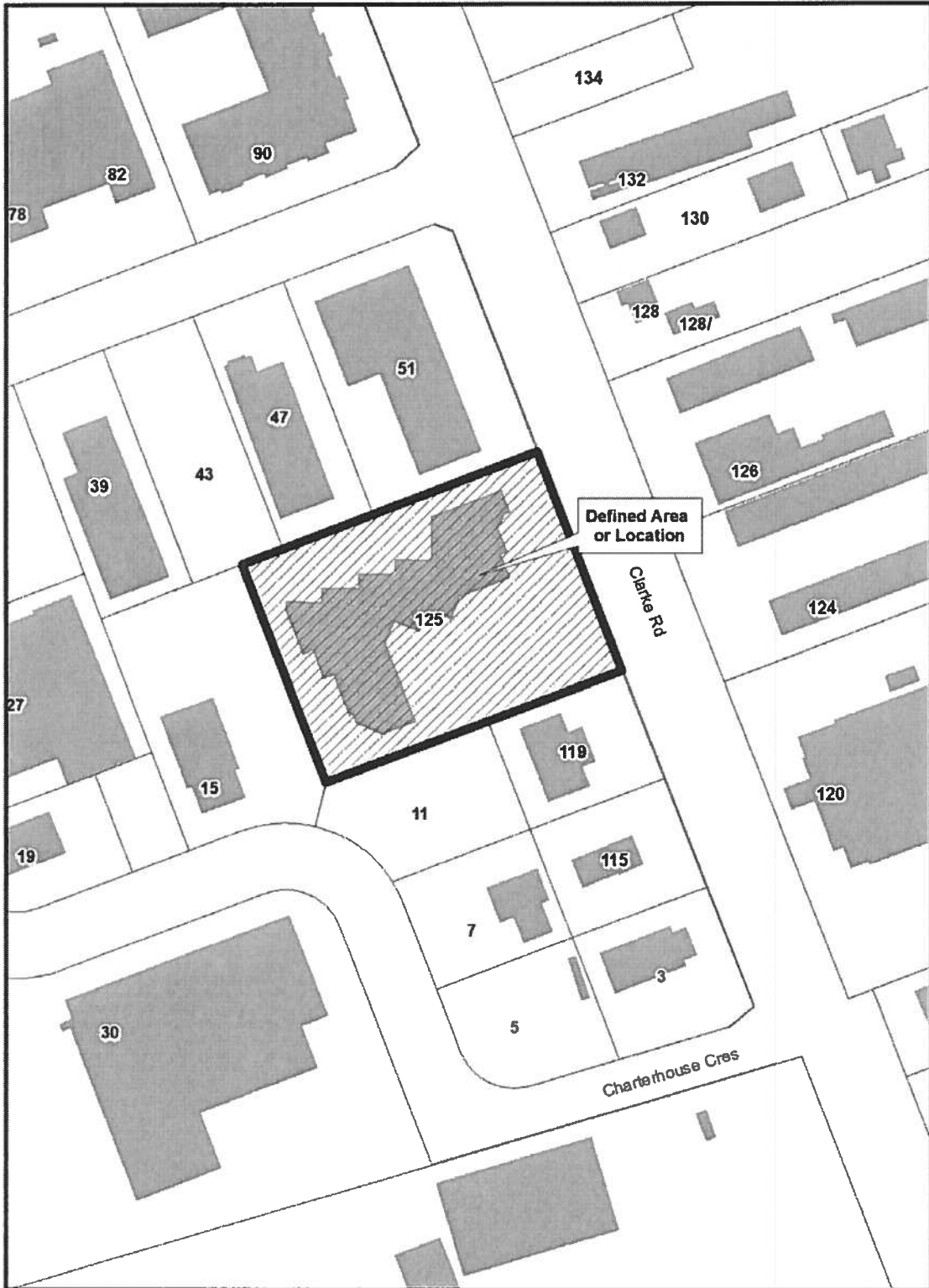

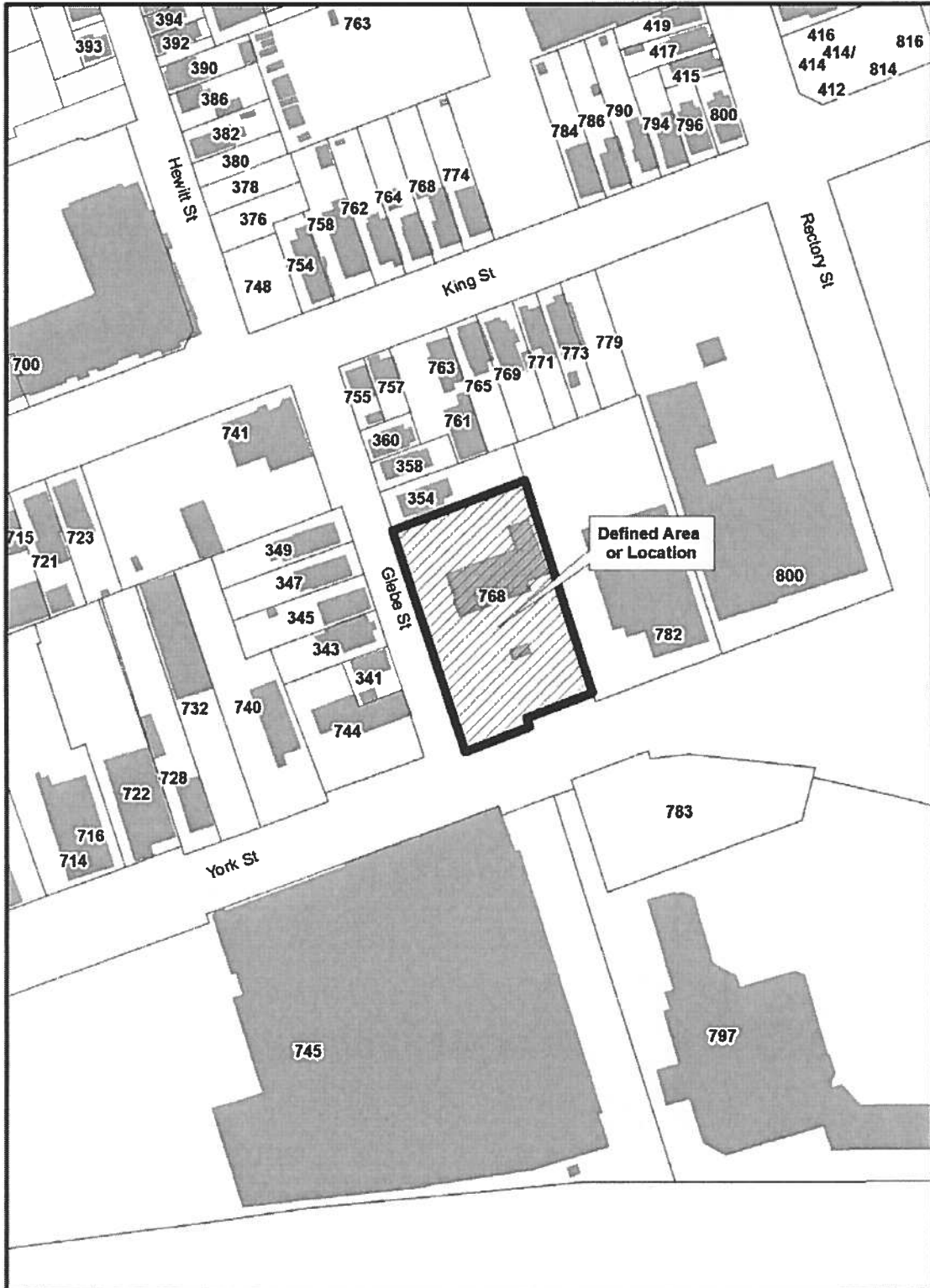

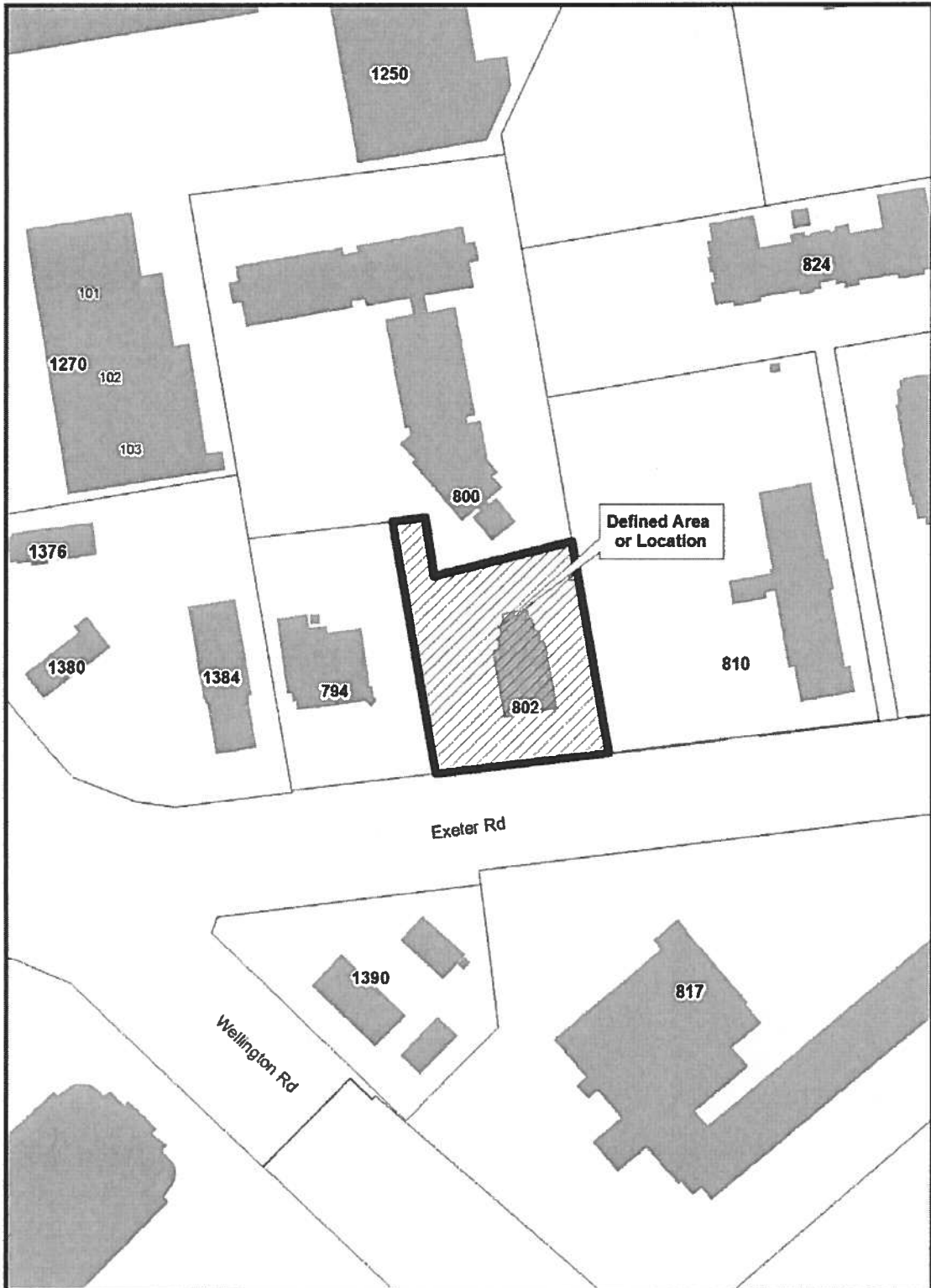
ADULT ENTERTAINMENT BODY-RUB PARLOUR LOCATIONS

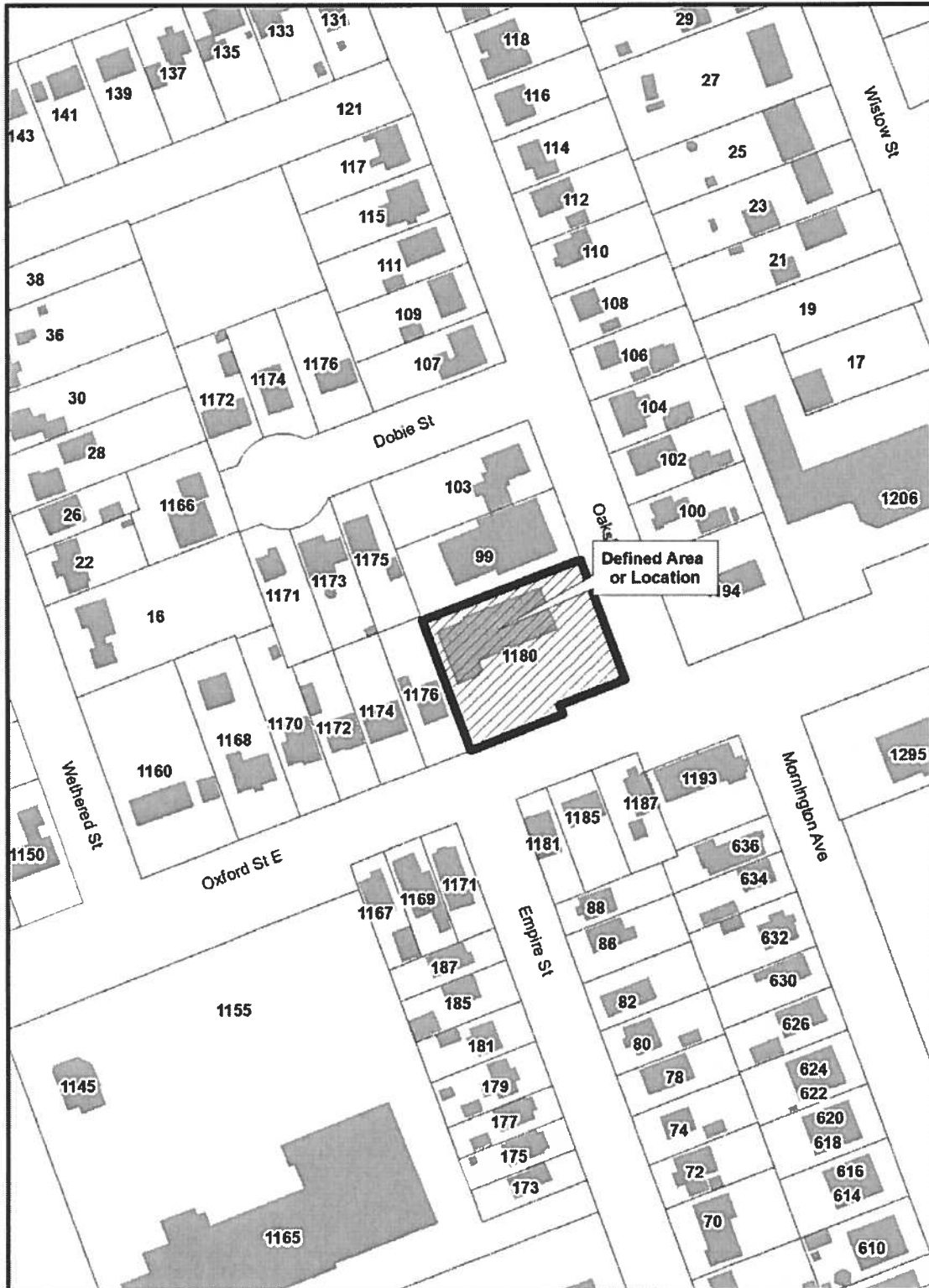

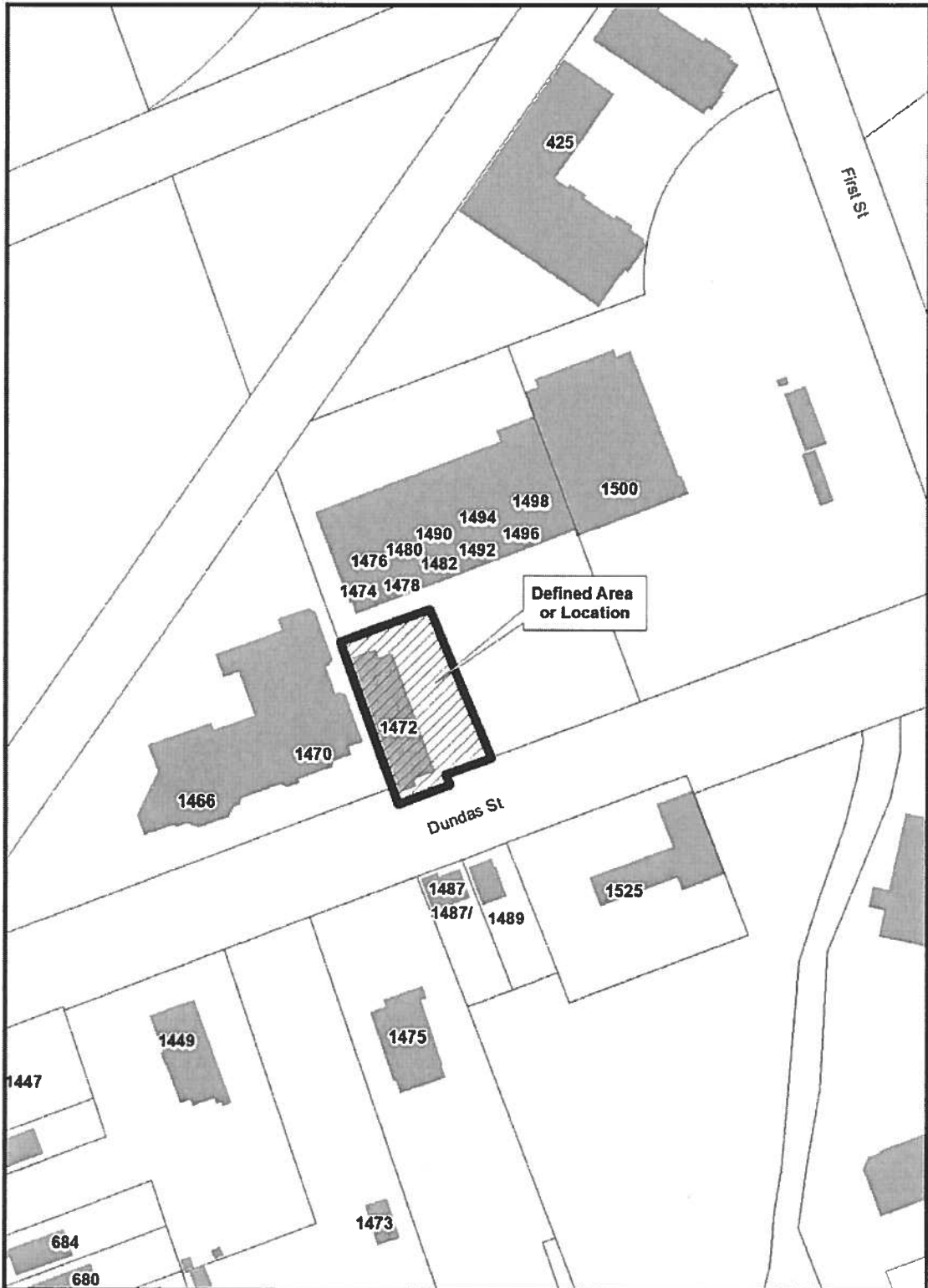

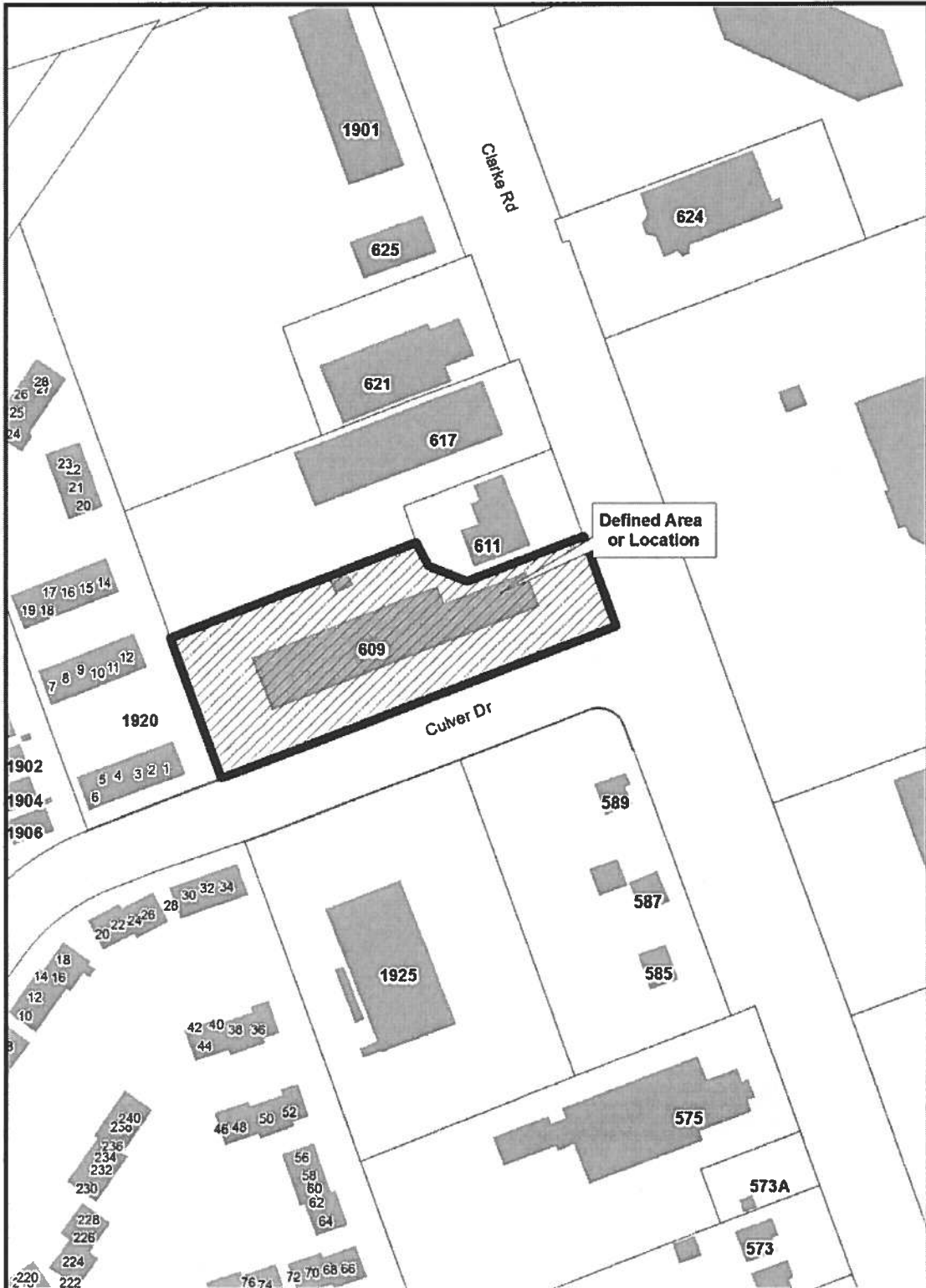

 Defined Area or Location







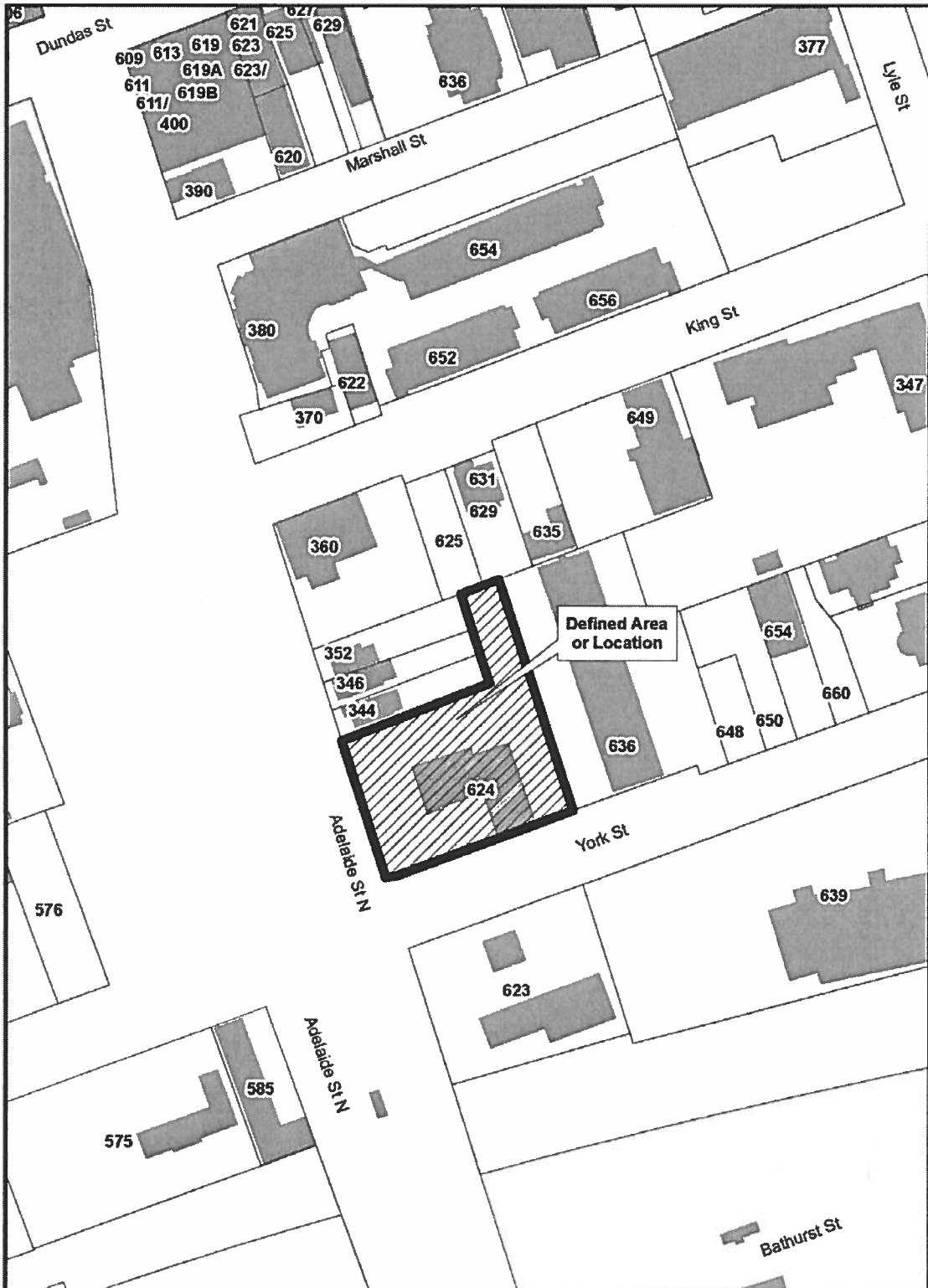
