SUBJECT	TENDER 12-74 CONSTRUCTION OF GLANWORTH MUNICIPAL DRAIN

RECOMMENDATION

That on the recommendation of the Acting Executive Director, Planning, Environmental & Engineering Services & City Engineer, the following actions **BE TAKEN** with respect to Tender 12-74:

- a) That the bid submitted by VanBree Drainage and Bulldozing Ltd., 7074 Navuoo Road, Warwick Twp., Ontario N0N 1J4 at their tendered price of \$306,545.00, HST extra **BE ACCEPTED**, it being noted that VanBree Drainage and Bulldozing Ltd. is the low bid and meets our terms, conditions and specifications in all areas.
- b) That financing for the project **BE APPROVED** in accordance with the "Source of Financing Report" attached hereto as Appendix "A"
- c) That Civic Administration **BE AUTHORIZED** to undertake all of the administrative acts that are necessary in connection with this contract;
- d) That approval hereby given **BE CONDITIONAL** upon the Corporation entering into a formal contract or issuing purchase orders or contract record relating to these matters of this approval.

BACKGROUND

Purchasing Process

Three (3) bids were received as a result of this tender call May 23, 2012 as summarized in Appendix "B" attached. VanBree Drainage and Bulldozing Ltd. is the overall low bid and meets the City's terms, conditions and specifications in all areas.

Purpose

The main objective of this report is to award the construction contract for the construction of the Glanworth Municipal Drain (ES4822) and to recommend that the Corporations Consultant (Spriet's Associates) carry out the inspection and contract administration necessary to complete and construct the drainage project.




Financial Impact
