PURCHASING PROCESS

Request for Proposal 12-07 was issued in March of 2012 and fifteen (15) submissions were received to provide services for Employment Placement, Essential Employment Services, Skills Training Directly Linked to Employment, Self Employment Development Services and Specialized Individual Support. Agencies could submit programs for one (1) or a combination of any or all programs. The submissions were evaluated by an evaluation team comprised of six (6) members from the Community Services Department, Finance and Corporate Services, and Purchasing and Supply. This team evaluated submissions based on a pre-determined set of criteria. The criteria consisted of:

- a) Alignment with the needs addressed in the Employment Assistance Framework 2013-2018;
- b) Capacity to provide the program(s);
- c) Labour market knowledge and community connections;
- d) Experience;
- e) Expertise;
- f) Proposal Presentation;
- g) References; and
- h) Program Content and Fees.

The evaluation team recommends acceptance of the submissions received from thirteen (13) agencies as they exhibited, strong organizational compositions, the financial capacity to deliver the programs, the technical resources and service sustainability. This provides services for all five (5) requested service areas.

BACKGROUND

On March 20, 2012, City Council approved the Ontario Works Employment Assistance Services Framework 2013 - 2018. A Request for Proposal Process was to be initiated to support the service delivery components of the new framework. The redesign of the service delivery model builds on the successes and strengths of the existing Framework and has been designed to address current realities. It will respond to participant needs and allow for a more flexible and timely response to labour market changes.

In the new framework, specific services were identified as being delivered by community partners and were the basis of this Request for Proposal. The organizations and services being recommended will provide the range of services and supports to assist in the achievement of the principles, goals and outcomes of the Ontario Works Employment Assistance Program. The services to be delivered include the following:

Essential Employment Services - Assists participants to prepare for, enter/re-enter the workforce and assists job-ready participants to find and maintain suitable employment. Employment Placement is a component of this service.

Skills Training Directly Linked to Employment - Assists participants in finding and maintaining suitable employment by improving their marketable skills through training and practical experience. Employment Placement is a component of this service.

Self Employment Development Services - Assists participants in developing and maintaining self employment.

Specialized Individual Support - Assists participants in addressing identified needs and barriers to support finding and maintaining suitable employment.

Employment Placement - Assists job ready participants to find and maintain suitable employment.

The Employment Assistance Service providers are integral to the effective delivery of Employment Assistance services and to the achievement of Employment Assistance outcomes.

The Employment Assistance components noted in this report provide crucial skills and supports for Ontario Works participants in their movement to self-sufficiency. Through this framework we will be better able to provide employment services that are more responsive changing Ontario Works participants, community and labour market demands.

FINANCIAL IMPACT

The 2012 Council approved budget includes funding for employment services and financial assistance for employment related expenses at \$8,622,234 (gross) or \$1,570,656 (net).

Funding for Employment Assistance is cost shared with the Ministry of Community and Social Services (MCSS) and includes a portion that will be uploaded with Ontario Works and funded 82.8% in 2012 and a portion that will be cost shared at 50%.
