That on the recommendation of the Director of Building Controls and Chief Building Official, the statistics report for Municipal Law Enforcement Services BE RECEIVED for information purposes.

## BACKGROUND

The attached chart summarizes occurrence activities on a monthly and year-to-date basis for Municipal Law Enforcement Services. The number of complaints year-to-date for 2012 increased by 280 in comparison to May 2011. The number of property clean-ups also more than doubled from 113 as of May 2011 to 230 as of May 2012. The file load and increase in clean-ups is attributed to a warm winter and property issues relate to St. Patrick's Day occurrences. The number of zoning files remains high as a direct result of zoning investigations related to the Residential Rental Units Licensing By-law.

Given the high volume of open files, all MLEO staff are currently assigned to inspection and field duties and the MLEO call centre was place on 24/7 voicemail. Previously, for the past three years, the call centre was staffed by MLEOs. Although this is not a customer service enhancement, the number of open files with no inspections is increasing and complaints with respect to MLEO response times are on the rise. Given the recent departmental reorganization, a staffed call centre may be resurrected in the future.
