- d) Approval hereby given **BE CONDITIONAL** upon the Corporation entering into a formal contract or having a purchase order relating to the subject matter of this approval.

Single Source report for the purchase of four (4) Ice Resurfacing Machines from Zamboni & Co., Ltd – Council Resolution November 8, 2011

BACKGROUND

Purchasing Process

Four (4) Ice Resurfacing Machines were purchased as a single source procurement January 2012 from Zamboni & Co., Ltd for use in the City arenas. Replacement parts will be necessary for the equipment and will be ordered "as and when" required for the life expectancy of these units. Zamboni & Co., Ltd. is the only supplier for the OEM replacement parts.

There are currently a total of fourteen (14) Zamboni Ice Resurfacing Machines that are used in the City arenas.

This recommendation is in compliance with our 'Procurement of Goods and Service Policy' as per Section 14.4 Single Source, clauses d and e.

Financial Impact

Funding for the OEM replacement parts is provided in the 2012 Current Operating Budget.
