London Pollution Prevention and Control Plan

The City of London initiated a Pollution Prevention and Control Plan (PPCP) in 2012 as part of its ongoing efforts to improve the performance of the City's sanitary and storm sewer infrastructure. The goal of the PPCP is to reduce and mitigate sewer system overflows (SSOs) and wastewater treatment plant (WWTP) and pumping station (PS) bypasses that are discharged into receiving streams during extreme wet weather events.

The PPCP was conducted in accordance with the master planning process following the requirements of Phases 1 and 2 of the Municipal Class Environmental Assessment process (October 2000, as amended in 2007, 2011 and 2015), which is an approved process under the Ontario Environmental Assessment Act. The PPCP addresses the need and the justification for SSO mitigation and recommends infrastructure projects that will be implemented in accordance with the next steps of the Municipal Class Environmental Assessment process.

Preferred mitigation measures were selected to reduce the SSOs and PS bypasses and include sewer separation projects, source control measures such as targeted weeping tile disconnection, inflow/infiltration reduction, and pipe capacity upgrades. Existing planned or recently completed infrastructure improvement projects that are aligned with the PPCP were also incorporated into the PPCP implementation plan.

The PPCP report has been prepared to document the planning and decision-making process undertaken for this environmental assessment. By this notice, the PPCP report is being placed on the public record for 30 calendar days for review from Tuesday, May 15, 2018 to Thursday, June 14, 2018.
