By-law No. S.-

A by-law to lay out, constitute, establish and assume certain reserves in the City of London as public highway. (As widening to Raleigh Boulevard, north of Pomeroy Lane; and As widening to Raleigh Boulevard, at Pomeroy Lane; And as widening to Pomeroy Lane, south of Raleigh Boulevard; And as widening to Pomeroy Lane, north of Raleigh Boulevard; And as to Settlement Trail and Pomeroy Lane; And as widening to Crane Avenue, south of Old Garrison Boulevard; And as widening to Settlement Trail, south of Old Garrison Boulevard; And as widening to Tillmann Road, north of Raleigh Boulevard.)

WHEREAS it is expedient to establish the lands hereinafter described as public highway;

THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

1. The lands and premises hereinafter described are laid out, constituted, established and assumed as public highway as widening to Raleigh Boulevard, north of Pomeroy Lane, namely:

“Part of Block 145 on Registered Plan 33M-458 in the City of London and County of Middlesex designated as Part 1 on Reference Plan 33R-15873.”

2. The lands and premises hereinafter described are laid out, constituted, established and assumed as public highway as widening to Raleigh Boulevard, at Pomeroy Lane, namely:

“All of Reserve Block 182 on Registered Plan 33M-624 in the City of London and County of Middlesex.”

3. The lands and premises hereinafter described are laid out, constituted, established and assumed as public highway as widening to Pomeroy Lane, south of Raleigh Boulevard, namely:

“All of Block 74 on Registered Plan 33M-494 in the City of London and County of Middlesex.”

4. The lands and premises hereinafter described are laid out, constituted, established and assumed as public highway as widening to Pomeroy Lane, north of Raleigh Boulevard, namely:

“All of Reserve Block 146 on Registered Plan 33M-621 in the City of London and County of Middlesex.”

5. The lands and premises hereinafter described are laid out, constituted, established and assumed as public highway as widening to Settlement Trail and Pomeroy Lane, namely:

“All of Block 73 on Registered Plan 33M-494 in the City of London and County of Middlesex.”

6. The lands and premises hereinafter described are laid out, constituted, established and assumed as public highway as widening to Crane Avenue, south of Old Garrison Boulevard, namely:

“All of Block 193 on Registered Plan 33M-562 in the City of London and County of Middlesex.”

7. The lands and premises hereinafter described are laid out, constituted, established and assumed as public highway as widening to Settlement Trail, south of Old Garrison Boulevard, namely:

“All of Block 194 on Registered Plan 33M-562 in the City of London and County of Middlesex.”

8. The lands and premises hereinafter described are laid out, constituted, established and assumed as public highway as widening to Tillmann Road, north of Raleigh Boulevard, namely:

“All of Reserve Block 147 on Registered Plan 33M-621 in the City of London and County of Middlesex; and

All of Reserve Block 184 on Registered Plan 33M-624 in the City of London and County of Middlesex.”

2. This by-law comes into force on the day it is passed.
