SUBJECT	AMENDMENTS TO THE TRAFFIC AND PARKING BY-LAW

RECOMMENDATION


That on the recommendation of the Managing Director, Engineering and City Engineer, the <u>attached</u> proposed by-law (Appendix "A") **BE INTRODUCED** at the Municipal Council meeting to be held on October 9, 2012 for the purpose of amending the Traffic and Parking By-law (P.S. 111).

BACKGROUND

The Traffic and Parking By-law (P.S.111) requires amendments (Appendix "A") to address traffic safety, operations and parking concerns. The following amendments are proposed:

1. No Stopping, No Parking, One Way Streets

- a) Due to safety concerns with narrow street width and vehicles parking on both sides of Devon Road it is proposed to create a No Parking Anytime zone on the south, east and north sides of the street between two cul-de-sacs. When vehicles are parked on both sides the road becomes too narrow for drivers to navigate and emergency vehicles to access the street. An amendment is required to Schedule 2 (No Parking).
- b) At the request of residents, a mail-back survey was conducted on Devos Drive to determine if the homeowners supported "No Parking Anytime" zone on the south side of the street from Grenfell Drive to Stackhouse Avenue. The results of the mail-back survey indicated that the majority of respondents supported the parking regulation change. An amendment is required to Schedule 2 (No Parking).
- c) Due to safety concerns with vehicles parking within the curves on Drummond Place, Edmunds Crescent, Georgeheirot Lane, Harcroft Crescent, Martinet Aveue and Quinton Road it is proposed to create a No Parking Anytime zones on the inside of the curves. Concerns have been expressed that if vehicles are parked on the inside of the curve the visibility is greatly reduced. An amendment is required to Schedule 2 (No Parking).
- d) At the request of residents, a mail-back survey was conducted on Optimist Park Drive to determine if the homeowners supported removal of the "No Parking Anytime" zone on the east side of the street from in front of Mun # 140 and Mun # 144 Optimist Park Drive. The results of the mail-back survey indicated that the majority of respondents supported the parking regulation change. An amendment is required to Schedule 2 (No Parking).
- e) Municipal staff received complaints that when vehicles are parked at the east end of Rachel Street it is difficult for residents to access their driveways and it prevents large vehicles such as moving trucks from turning around. An amendment is required to Schedule 2 (No Parking) to prevent vehicles from parking within the 20 meter end zone.
- f) Parking bays with curb extensions were constructed on the west side of Repton Avenue as a traffic calming measure. On-street parking restrictions should be moved from west to east side to accommodate the change and parking should be prohibited in the narrow areas of the street. An amendment is required to Schedule 2 (No Parking).



- g) Due to safety concerns at pedestrian traffic signal on Springbank Drive and Trowbridge Avenue it is proposed to designate the south side of Springbank Drive a No Stopping zone from pedestrian crosswalk and 45 m westerly. Concerns have been expressed that delivery vehicles blocking the view of the crosswalk for eastbound traffic when stopping in the curb lane close to the crosswalk. An amendment is required to Schedule 1 (No Stopping).
- h) At the request of residents, a mail-back survey was conducted on Trowbridge Avenue to determine if the homeowners supported "No Parking 8:00 am 6:00 pm, Monday-Friday" zone on the west side of the street from Springbank Drive to the north end of the street. The results of the mail-back survey indicated that the majority of respondents supported the parking regulation change. An amendment is required to Schedule 2 (No Parking).

2. Bicycle Lanes

- a) Bicycle lanes were recently introduced at the following locations:
 - Dundas Street from Thames Street to Ridout Street North
 - Fanshawe Park Road East from McLean Drive to 275 m east of Highbury Avenue
 North
 - Highbury Avenue North from Kilarney Road to Blackwell Boulevard
 - Queens Avenue from Talbot Street to Riverside Drive
 - Riverside Drive between Woodward Avenue and Queens Avenue/Dundas Street
 - Southdale Road East from Willow Drive to Pond Mills Road

Amendments are required to Schedule 9.1 (Reserved Lanes).

3. Regulatory Signs


- a) New yield signs are required to address right-of-way control in a new subdivision at the following intersections:
 - Canvas Way at Eclipse Walk
 - Jackpine Way at Kleinburg Drive
 - Kleinburg Drive at Canvas Way
 - Westpoint Heights at Savoy Street
 - Westwick Walk at Beattie Street
 - Westwick Walk at Westpoint Heights
- b) Due to ongoing safety concerns with respect to intersecting streets controlled by yield signs it is proposed to replace existing yield signs with stop signs at the following locations:
 - Bayswater Crescent at Coronation Drive
 - Tanoak Drive at Coronation Drive

Amendments are required to Schedule 11 (Entering Highway - Yield Signs).

4. Revised Speed Limits

a) As a result of recent development in the area, Sunningdale Road West was reviewed against City's speed limit policy. It is proposed to reduce the speed limit on Sunningdale Road West between Wonderland Road North and Denview Avenue from 80 km/h to 70 km/h.

An amendment is required to Schedule 17 (Higher Speed Limits).



5. Heavy Truck Restrictions

a) In recent years the by-law was amended to allow school buses to park on City streets during school hours so that the bus did not have to return to the depot between pickingup and dropping-off students. An amendment is required to Section 27 (Heavy Truck Restrictions) to maintain consistency with the previously approved amendment.

6. Typographical Errors

- a) A review of the "No Parking" and the "Limited Parking" Sections of the by-law revealed incorrect limits on the south side of Blackfriars Street from Wilson Avenue to Blackfriars Bridge.
- b) A review of the "No Parking" Section of the by-law revealed incorrect limits on the west side of St. George Street between Oxford Street and Mill Street.
- c) A review of Schedule "27" (Designated Parking Spaces-Disabled Persons) identified a typographical error in the description of the zone on St. James Street.

An amendment is required to Schedule 2 (No Parking) and Schedule 27 (Designated Parking Spaces-Disabled Persons).



APPENDIX "A" BY-LAW TO AMEND THE TRAFFIC & PARKING BY-LAW (P.S. 111)

Bill No.

By-law No. PS-111

A by-law to amend By-law PS-111 entitled, "A by-law to regulate traffic and the parking of motor vehicles in the City of London."

WHEREAS subsection 10(2) paragraph 7. of the *Municipal Act, 2001*, S.O. 2001, c.25, as amended, provides that a municipality may pass by-laws to provide any service or thing that the municipality considers necessary or desirable to the public;

AND WHEREAS subsection 5(3) of the *Municipal Act*, 2001, as amended, provides that a municipal power shall be exercised by by-law;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:




