## **APPENDIX "A"**

Bill No. 2011

By-law No.

A By-law to amend By-law No. A-40, entitled "A by-law to provide for Various Fees and Charges"

WHEREAS section 5(3) of the *Municipal Act*, 2001 S.O. 2001, c.25, as amended, provides that a municipal power shall be exercised by by-law;

AND WHEREAS sections 9, 10 and 391 of the *Municipal Act, 2001*, S.O. 2001, c.25, as amended, authorize a municipality to impose fees or charges on persons for various services or activities and for the use of its property;

NOW THEREFORE the Council of The Corporation of the City of London enacts as follows:

- 1. By-law A-40 is amended by deleting the fee of "\$150" contained in "Schedule 1 Service Grouping: Public Support Services, Business Licensing, Officiating Marriages" and replacing it with a fee of "\$250, with an additional fee of \$25 per witness, if required".
- 2. This by-law shall come into force and effect on the day it is passed.
