We deal with not only the emergent medical issues but also the social issues that contribute to the health emergencies people face. As a result, I am attuned to the barriers faced in the community to ensuring maintenance of good physical and mental health which will help me serve effectively on the Middlesex-London Health Unit board.**

**Interest reason: I would like to serve on the Middlesex-London Health Unit because I am passionate about ensuring the health and well-being of the public. I have spent 10 years at the front line of health care delivery and recognize the critical role community health protection and health promotion programs play in preventative care. On a daily basis, I see to the health-care needs of our vulnerable populations including the elderly, the young and the underprivileged. As a result, I recognize where preventative health programs could have mitigated a patient's need to escalate to a call for service from the emergency health care system. I believe public health programs are essential to the overall sustainability of health care in Canada.**

**Contributions: I believe I can bring a front-line perspective to the Health Unit board through my experience in Emergency Medical Service and understanding of current and emerging risks to community health. My experience as part of the management staff at Oxford County EMS also gives me the insight into health protection and promotion programs being offered by neighbouring regions.**

I have helped prepare two budgets for EMS and am integral in the creation of policy and new initiatives for ambulance service in Oxford County. I am also a member of the senior management team for Oxford County Public Health and Emergency Services. As a result of my experience in prehospital care and public health, I have been a member of committees including regional stroke strategy, cardiac care and prehospital research consortiums with the goal of creating seamless and integrated community health care. To that end, I am currently designing a program for EMS to bridge our health care clients with appropriate services and resources throughout the community and help divert patients from the Emergency Room. During my tenure with the Canadian Coast Guard, I served on the St. Lawrence Emergency Response Association building and maintaining stakeholder relationships to improve service delivery and rescue capacity to the marine community in the St. Lawrence River region. At the Urban League, I am involved in annual citizen review of the municipal budget and provide commentary and recommendations to City Council. I have been a representative to key task forces including the City's Official Plan Review. I have also sat on the Ontario Base Hospital Group executive, the Advisory Committee on the Environment, the Environmental and Ecological Planning Advisory Committee, the Advisory Committee on Deerness Services, the Old South Community Organization and the Board of ReForest London.**
