SUBJECT	AMENDMENTS TO THE TRAFFIC AND PARKING BY-LAW

RECOMMENDATION

That on the recommendation of the Managing Director, Environmental & Engineering Services and City Engineer, the <u>attached</u> proposed by-law (Appendix "A") **BE INTRODUCED** at the Municipal Council meeting to be held on December 11, 2012 for the purpose of amending the Traffic and Parking By-law (P.S. 111).

BACKGROUND

The Traffic and Parking By-law (P.S.111) requires amendments (Appendix "A") to address traffic safety, operations and parking concerns. The following amendments are proposed:

1. No Parking

- a) Little Simcoe Street was recently reconstructed and parking bays were installed as a traffic calming measure. On-street parking should be prohibited in the narrow areas of the street. An amendment is required to Schedule 2 (No Parking).
- b) At the request of residents, a mail-back survey was conducted on Tanoak Drive to determine if the homeowners supported the creation of a "No Parking, 8:00 am to 5:00 pm, Except Saturdays" zone on the west side of the street from Hawthorne Road to Jasmine Drive. The results of the mail-back survey indicated that the majority of respondents supported the parking regulation change. An amendment is required to Schedule 2 (No Parking).

2. Typographical Errors

A review of the by-law found some typographical errors in Schedule 2 (No Parking). The section related to Repton Avenue, east side from Firefly Avenue to Phillbrook Avenue, No Parking Anytime will be removed. It is also necessary to revise Phillbrook Avenue to Phillbrook Drive.

3. Unlicensed Vehicles

City's Parking Enforcement Office has requested a by-law amendment to include a definition of "Unlicensed Vehicle" and prohibit parking of unlicensed vehicles on City streets. It is proposed to amend Part 7 "Municipal Councillor's Off Street Parking" and "Section 78 Deleted" with "Part 7 Unlicensed Vehicles" and "Section 78 Unless otherwise permitted in this By-law, no person shall park a vehicle on any highway if such vehicle is an unlicensed vehicle."

It is necessary to add "Unlicensed Vehicle" to Definitions Section 1.

"Unlicensed Vehicle" means a motor vehicle that does not have a number plate displayed or does not have current validation of a vehicle permit affixed to the number plate, in the manner prescribed in the Highway Traffic Act;

APPENDIX "A" BY-LAW TO AMEND THE TRAFFIC & PARKING BY-LAW (P.S. 111)

Bill No.

By-law No. PS-111

A by-law to amend By-law PS-111 entitled, "A by-law to regulate traffic and the parking of motor vehicles in the City of London."

WHEREAS subsection 10(2) paragraph 7. of the *Municipal Act, 2001*, S.O. 2001, c.25, as amended, provides that a municipality may pass by-laws to provide any service or thing that the municipality considers necessary or desirable to the public;

AND WHEREAS subsection 5(3) of the *Municipal Act*, 2001, as amended, provides that a municipal power shall be exercised by by-law;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

1. No Parking

Schedule "2" (No Parking) of the said By-law PS-111 is hereby amended by **deleting** the following rows:

Little Simcoe Street	North	Rathmine St	Rectory St	Anytime
Repton Avenue	East	Firefly Dr	Philbrook Avenue	Anytime
Repton Avenue	East	Sandybrook Dr	Phillbrook Avenue	Anytime

And by adding the following row:

Little Simcoe Street	North	Rectory St	A point 63 m west of said street	Anytime
Repton Avenue	East	Sandybrook Dr	Phillbrook Dr	Anytime
Tanoak Drive	West	Hawthorne Rd	Jasmine Dr	8:00 am to 6:00 pm, Except Saturdays

2. Part 7 - Municipal Councillor's Off Street Parking, Section 78 Deleted

Part 7 - Municipal Councillor's Off Street Parking, Section 78 Deleted of the said By-law PS-111 is hereby amended by replacing with the following:

Part 7 - Unlicensed Vehicles, Section 78. (1) Unless otherwise permitted in this By-law, no person shall park a vehicle on any highway or parking space if such vehicle is an unlicensed vehicle.

Section 1. Definitions is hereby amended by adding the following:

"Unlicensed Vehicle" means a motor vehicle that does not have a number plate displayed or does not have current validation of a vehicle permit affixed to the number plate, in the manner prescribed in the Highway Traffic Act;

3. This by-law comes into force and effect on the day it is passed.
