"Extra Sheet" Attachment (Ross): What do you hope to contribute or learn as part of an Advisory Committee?

As a PhD candidate studying the intersection of ecology, religion and sexuality, I bring a unique expertise to local social and ecological issues. My work explores religious responses to climate change and ecological crises as well as environmental ethics and social justice movements. My doctoral dissertation connects ecological, ecotheological and ecofeminist discourses with sexual ethics and new LGBTQ rights movements. I have taught ethics courses at the University of Toronto and at King's University College in London. I have also worked as a teaching assistant and a Liaison Officer at King's.

As I approach the end of my formal education, I am hoping to diversify my experience outside of the university and to get more involved in local issues. I have a strong passion for environmental issues with a particular interest in how belief systems or ethical frameworks inform environmental practice. After many years in the classroom as a teaching assistant and instructor, I believe that one of my strongest assets is an ability to mediate constructive dialogue between divergent viewpoints on controversial subjects, and I am excited to apply my background and knowledge to municipal issues.
