SUBJECT:	TENDER 13-06 RENTAL OF GENERAL EQUIPMENT WITH OPERATORS

RECOMMENDATION

That on the recommendation of the Managing Director, Environmental & Engineering Services & City Engineer, this report **BE RECEIVED** and reported to Municipal Council for their information with respect to the Rental of General Equipment with Operators.

- a) The bids submitted for the Rental of General Equipment with Operators at their tendered prices for a two (2) year period **BE ACCEPTED**;
- b) The Civic Administration **BE AUTHORIZED** to undertake all the administrative acts that are necessary in connection with this project, and
- c) Approval hereby given **BE CONDITIONAL** upon the Corporation entering into a formal contract or having a purchase order or contract record relating to the subject matter of this approval.

BACKGROUND

Purchasing Process

Twenty-nine (29) bidders submitted prices on up to 26 categories of equipment as a result of a tender call December 29, 2012. A list of successful bidders is attached as Appendix "A".

All successful bidders will be placed on a call-in list ordered by price and will be contacted to perform work on an as required basis, based on a combination of:

- category of equipment
- tendered hourly unit prices;

Each failure of successful bidders to provide equipment when called and each mechanical breakdown will be recorded. After recording three failures on the part of the bidders, they will be removed from the respective list at the City's discretion.

Types of equipment include dump trucks, excavators, loaders and sweepers. Work performed supplements City-owned equipment and includes road maintenance, sewer and watermain repair as well as re-construction of sewers and watermains by City forces.

Note that listed bidders in Appendix "A" may be successful in some equipment categories but not in others. A detailed summary of bids listing hourly rates, and equipment can be obtained from Purchasing and Supply.

Financial Impact



