







# **Context: The History**





### **Context: Understanding the Language**

Affordable Housing provides up-front capital funds to reduce carrying costs, such as mortgages, to keep ongoing costs/rents low. Almost 1100 units of affordable housing were developed under the Affordable Housing Program.

**Social Housing** requires ongoing operating subsidy to adjust rental costs based on tenant eligibility and income and waiting list priority. *Social Housing was divested to municipalities in 2000 from the Province and exists within public, non-profit, private, and co-operative housing.* 

London and Middlesex Housing Corporation is often referred to as London Housing or **Public Housing** as the City is their sole shareholder. *LMHC is the largest of many social housing providers with almost 3300 of over 8000 total units.* 

**Supportive Housing** provides comprehensive and long term in-home supports for those requiring more intensive assistance to daily needs. *These housing solutions continue to be provided through health and other sectors.* 

**Housing with Supports** refers to in-home supports to daily living that are provided to those able to otherwise reside within market or other standard community housing options. *London CAReS is piloting housing with supports for those experiencing chronic homelessness.* 

Homelessness refers to situations where individuals or families have either no home (including those in shelters) or are at imminent risk of losing their home. Housing First refers to the priority of housing solutions and includes supporting the unique underlying needs to staying housed.








# **Context: Current Legislative Framework**

#### THE HOUSING SERVICES ACT (HSA)

- Requires a new 10-year local integrated housing and homelessness plans from Service Managers (SM), including areas of provincial interest.
- SMs will have opportunity for more flexible programs and services in affordable housing and the elimination of some areas previously requiring MMAH consents.
- Areas requiring review, amendment, or development of new local rules and processes. Eg. Opportunity for SMs to change the waiting list processes.
- Provides the Housing Services Corporation more flexibility to offer new services and supports.





### **Context: Funding Framework**

#### **INVESTMENT IN AFFORDABLE HOUSING (IAH):**


- > A Fed./Prov. bilateral agreement covering 2011-2014 harmonizing investments and reporting related to affordable housing.
- ➤ Replaces funding previously provided separately for affordable housing initiatives from Fed., CMHC, and Prov. and aligns within HSA. \$13.6 million to March 2015.
- Four general categories:
  - 1. Increasing supply of affordable housing,
  - 2. Improving affordability for those in housing crisis,
  - 3. Improving/preserving the quality of affordable housing, and
  - 4. Supporting safe independent living.

Options for Affordable Living




Integrated Community Plan on Homelessness with a roadmap of actions

### **Theme 1: Strong System Design**

#### Brief Update:

The Housing Services Act together with the Housing Strategy have led to....

- > New and updated local rules for social housing (in progress)
- > Redesign of London CAReS (2011/2012) focusing on Housing First for those with complex homelessness needs
- > 2012 New Federal Provincial Investing in Affordable Housing (IAH) funding allowing for a "toolbox" approach to housing solutions and targets
- > Creation of a municipal housing supplement with supports aligned with London CAReS
- Ongoing decentralization in Ontario Works with a new service site at LUSO
- > System reengineering work guided by the Child and Youth Network's Neighbourhood Engagement and Development in identified priority neighbourhoods
- > Revising strategy and plan into an updated 10 year Housing and Homelessness plan
- > Ongoing discussions with health and other sectors related to housing

### **Theme 2: Integrated Responses**

#### Focus on retooling London CAReS within a Housing First approach

Brief Update:

- > Strengthened focus on integrated services and housing supports
- ➤ Enhanced co-ordinated work of street outreach, housing locator, and housing supports
- > Continued deployed through new service contracts with community partnerships,
- More co-ordinated recruitment, training, and action.

#### Focus on responding through new Community Homelessness Prevention Initiative

- New provincial funding consolidating 5 program based funding allocations
- Increased local flexibility
- > Authorized within the Housing Services Act and aligned locally within a revised 10 year strategy
- > End of Community Start-up and Maintenance benefit in social services (OW and ODSP)
- > New services will be aligned within 3 key areas of integrated homelessness services:
  - Securing Housing (related to those at risk or currently experiencing homelessness)
  - Supports (related to staying safely and appropriately housed)
  - Stabilizing Housing (retaining housing as part of broader community engagement

- Dialogue within the grassroots community groups reflecting interest in safe and affordable housing



Social Service Delivery: Continued local responses to caseload growth and other challenges through


specialized teams, new employment services contracts, actively engaging in the provincial social service review, and piloting new technologies to allow for


improved access to services.






# **A Tool Box of Outcome Based Housing Options**

Based on the needs and capacities of individuals families, and communities Working ACROSS NOT WITHIN programs, services, or systems toward shared goals.



### **Current Priorities and Next Steps**

- 1. Reviewing and revising local rules for social housing to ensure they meet new legislation. Creating and monitor new rules as needed. (Eg. Review system)
- 2. Continuing to develop new affordable housing options within a toolbox approach. (Eg. Engage private market landlords in new supplement programs.)
- 3. Continue to support existing promising programs, including London CAReS 2.0 shift to a housing focus. Assisting in new service approaches to homelessness prevention and intervention under CHPI.
- 4. Exploring new service options within the revised legislation and local and Fed/Prov. Funding through Council Housing Leadership Committee
- 5. Policy and process review of housing access to consider choice based and other options available within new HSA.
- 6. Developing new 10 year housing and homelessness plan for 2014.
