
A by-law to amend By-law No. Z.-1 to rezone an area of land located at 3841 Cheese Factory Road and 1605 Max Brose Drive.

WHEREAS an application has been received to rezone an area of land located at 3841 Cheese Factory Road and 1605 Max Brose Drive, as shown on the map attached to this by-law, as set out below;

AND WHEREAS this rezoning conforms to the Official Plan;

THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

- 1. Schedule "A" to By-law No. Z-1 is amended by changing the zoning applicable to lands located at 3841 Cheese Factory Road, as shown on the attached map comprising part of Key Map No. 151, from a Light Industrial (LI1) Zone to an Open Space (OS5) Zone;
- 2. Schedule "A" to By-law No. Z-1 is amended by changing the zoning applicable to lands located at 1605 Max Brose Drive, as shown on the attached map comprising part of Key Map No. 151, from a Light Industrial (LI/LI2/LI6) Zone to a Light Industrial Special Provision (LI1(_)/LI2(_)/LI6(_)) Zone; and
- 3. Section Number 40.4 of the Light Industrial (LI1/LI2/LI6) Zone is amended by adding the following Special Provisions:
 - LI 1(_)) Regulations a) Landscaped East Side 10 metres Yard Depth (33 ft) (m) Minimum) LI 2() a) Regulations Landscaped East Side 10 metres Yard Depth (33 ft) (m) Minimum) LI 6(_) Regulations a) Landscaped East Side 10 metres Yard Depth (33 ft) (m) Minimum
- 4. The inclusion in this By-law of imperial measure along with metric measure is for the purpose of convenience only and the metric measure governs in case of any discrepancy between the two measures.
