RECOMMENDATION

That on the recommendation of the Managing Director - Environmental & Engineering Services & City Engineer,

- a) That approval hereby **BE GIVEN** to enter into annual negotiations and obtain a supply contract for a one (1) year period with options to renew for two (2) additional one (1) year periods for the purchase of Reflective Marking Material with 3M Canada Company, P.O. Box 5757, London, ON N6A 4T1;
- b) That the Civic Administration **BE AUTHORIZED** to undertake all the administrative acts that are necessary in connection with this contract; and
- c) That approval hereby given **BE CONDITIONAL** upon the Corporation negotiating satisfactory prices, terms and conditions with 3M Canada Company to the satisfaction of the Director of Roads and Transportation; and
- d) Approval hereby given **BE CONDITIONAL** upon the Corporation entering into a formal contract or having a purchase order relating to the subject matter of this approval.

BACKGROUND

Purchasing Process

In 2012 purchases totalled \$94,539 (excluding HST). Products will be purchased into inventory as required. Funding for reflective marking material is provided in the 2013 Current Operating Budget, subject to Council approval.

3M Canada Company is the manufacturer and only sells directly to clients which results in distributors electing not to respond to requests for competitive bids. In addition 3M has held pricing with no increase for 2009, 2010, 2011 and 2012 purchases.

3M is the world leader in retroflective technologies and is partnered with government agencies for education and sharing of research to enhance the visibility of the roadway to enable drivers to make the safest driving decisions.

Purchasing Process...cont'd

3M's innovative approach to traffic safety ensures that our sign sheeting objectives are met; their products are designed for durable traffic control signs, work zone signs and delineators offering a low cost and high value to us.

Brighter signs are a tool for providing safer roads for the City, especially at night when there is a three (3) times greater risk. 3M's technology features provides drivers with the ability to read and understand sign's messages faster, requiring less eyes off the road time, leaving drivers more time to attend to the task of driving.

3M's products meet ASTM D4956 Type III, Type IV and Type X specifications their reflective sheeting is nearly twice as bright on average as other prismatic sign sheeting and has a life expectancy of 12 years as opposed to 10 years for lower performance products.

This recommendation is in compliance with our 'Procurement of Goods and Services Policy' as per Section 14.4 Single Source, Clauses d and e.

Financial Impact

There are no additional operating costs associated with this project.
