<b>BACKGROUND</b>

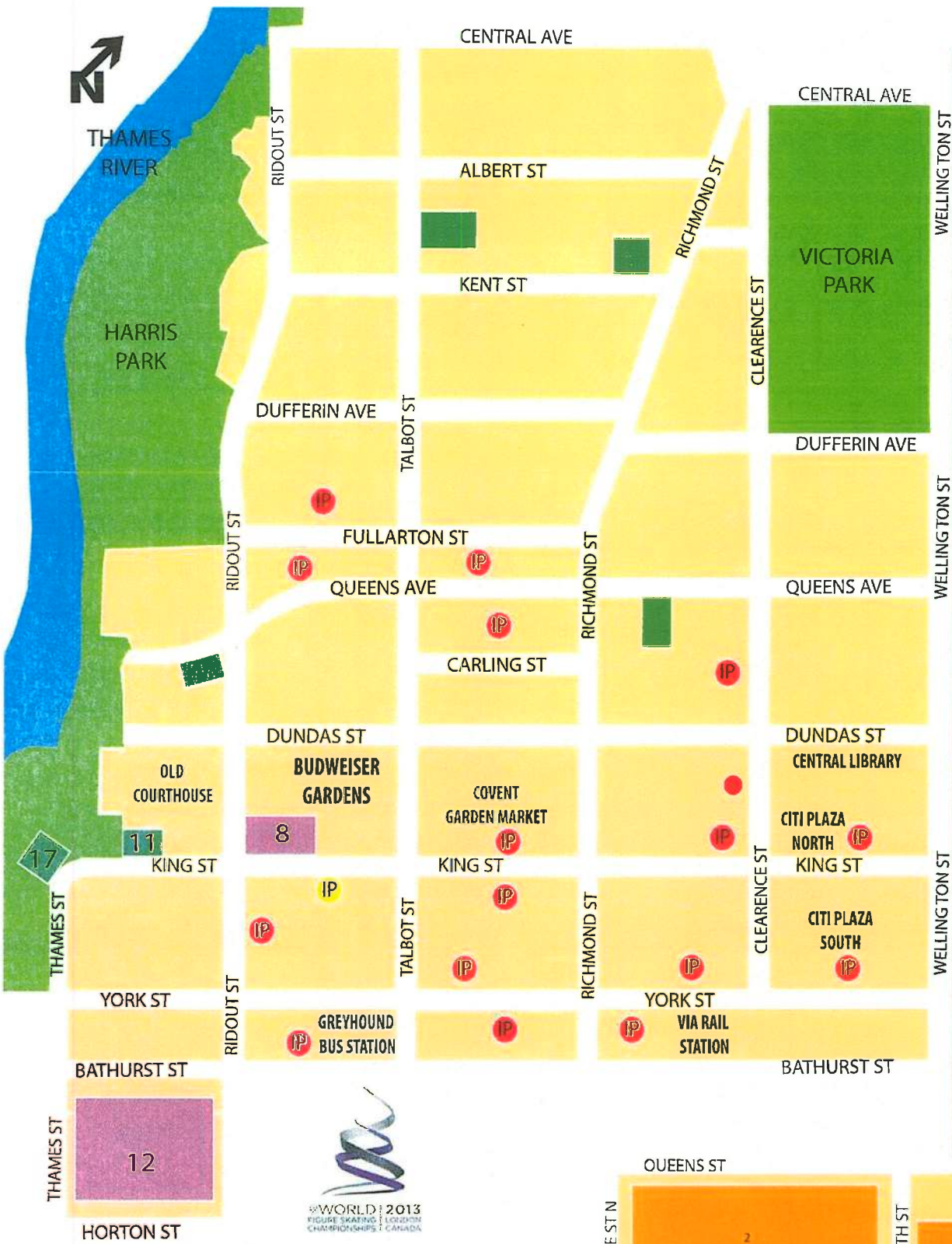
At the Municipal Council meeting on January 15, 2013 Councillor Armstrong enquired about what could be done to avoid excessive parking rates and fines being charged by private parking lot operators during the World Figure Skating Championships.

City Administration has reviewed Business Licensing By-laws and case law relating to the regulation of parking rates and fines charged by private parking lot operators. An attempt by the City of Toronto to regulate through its licensing by-law rates for parking violations charged by commercial parking lot owners and operators was unsuccessful in the courts. While a court has not considered the validity of a by-law that regulates parking rates, court decisions indicate that attempts to regulate parking rates would be problematic. A by-law to regulate the amount of rates or charges would require extensive study and public consultation. Such by-law would most likely be challenged in the courts.

Since the announcement was made about the World Figure Skating event, the City's parking office has been working with Tourism London and Skate Canada on providing parking opportunities in the downtown area. (see attached map). Private parking lot operators were also consulted.

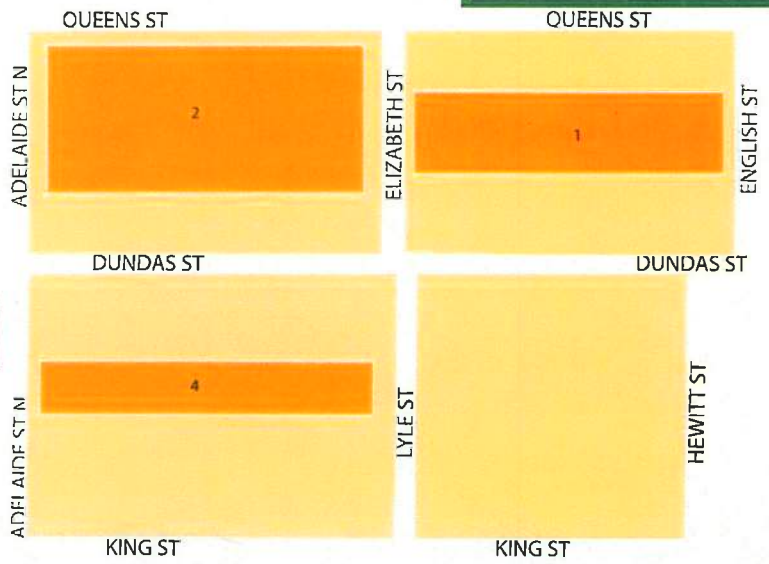

### The City of London and London Transit Park and Ride Pass \$60

Park your vehicle at one of the three municipal lots (Lot 1, 2, 4) located north and south of Dundas Street with access from Adelaide Street, Elizabeth Street, and Queens Avenue and take the London Transit bus downtown.

Passes are available at City of London Parking Division at 824 Dundas Street East. The cost of pass covers parking at a designated lot location and bus traveling on Dundas Street between English and Ridout Street. The buses that will be available are the 2 DUNDAS, 7 WAVELL, and 20 CHERRYHILL anytime Monday - Sunday.
