By-law No. S.-_____

A by-law to lay out, constitute, establish and assume lands in the City of London as public highway. (as widening to Oxford Street West, east of Royal York Road; as widening to Oxford Street West, between Royal York Road and Old Hunt Road; as widening to Oxford Street West, west of Old Hunt Road; as widening to Oxford Street West, between Sanatorium Road and Headley Gate; and as widening to Oxford Street West, east of Headley Gate)

WHEREAS it is expedient to establish the lands hereinafter described as public highway;

THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

1. The lands and premises hereinafter described are laid out, constituted, established and assumed as public highway as widening to Oxford Street West, east of Royal York Road, namely:
