# **How to Submit Your Letter**

- Your letter must be received at the CRTC by 8:00 p.m. Ottawa time <u>Friday April 5th</u>, <u>2013</u>. Letters received after this date <u>will not</u> be accepted by the CRTC.
- Please note that you must send a separate copy of your letter to Bell. The CRTC website does not provide the ability to copy an applicant directly. Instructions to do so are at the bottom of this document.
- Please ensure your letter is addressed to:

- Please include the line \*\*\*End of document\*\*\* following the last paragraph of your letter if you plan to submit your letter electronically. This will help indicate to the CRTC that your letter was not damaged in any way during electronic transmission. Please also include a "cc: Bell" at the conclusion of your letter to indicate to the CRTC that a copy will be sent to Bell.
- Your letter of support can be sent to the CRTC online via their website, by fax or by mail:

### Online via the CRTC website

- i. Go to the CRTC's website at <a href="www.crtc.gc.ca">www.crtc.gc.ca</a>. In the middle of the Home page, under "Public Proceedings", click the link for "Broadcasting proceedings open for comment".
- ii. Scroll down to Notice Number 2013-106 and click on "Submit".
- iii. Choose "I Agree" following the Terms of Use statement.
- iv. Select "Option #1 Submit an intervention or comment.
- v. Select "2013-0244-7: Astral Media Inc."
- vi. Indicate that your comments are "in support" of the application, and insert your comments in the field provided <u>OR</u> browse and upload the letter you wish to submit from your computer.
- vii. In the next step, you will be asked if you wish to appear at the hearing. If you request to appear, you will be asked to provide a reason why. You may simply indicate that you would like to expand on your written submission.
- viii. Follow the remaining steps until the process is complete. After filling out the form with your personal information, please ensure to check the box next to the statement "I will be sending a copy of my comments to the applicant and to any other person that the Commission has directed. I agree to provide proof to the Commission upon request." Please note that you must send a separate copy of your letter to Bell. The CRTC website does not provide the ability to copy an applicant directly.
