By-law No. Z.-1-132173

A by-law to amend certain portions of text
within By-law No. Z.-1.

The Municipal Council of The Corporation of the City of London enacts as follows:

CITY OF LONDON ZONING BY-LAW
BY-LAW NO. Z.-1 AMENDMENT

1. By-law Z-1 is amended by replacing Schedule A and Schedule B with the new attached Schedule "A" and Schedule "B", the originals of which are in a 34" X 44" format. The attached Schedules "A" and "B" to this by-law are legal size 8 ½ X 14 for illustration purposes only.
2. Section 3.11 to By-law No. Z.-1 is amended as follows:
 - deleting the text "Maps 126 and 127" in the second paragraph and replacing it with the text "Map A106";
3. Section 50.2 to By-law No. Z.-1 is amended as follows:
 - 50.2.10) delete the number "90" and replace it with the text "A109";
 - 50.2.14) delete the number "69" and replace it with the text "A107";
 - 50.2.18) delete the number "103" and replace it with the text "A107";
 - 50.2.27) delete the number "68" and replace it with the text "A107";

 - 50.2.52) delete the number "142" and replace it with the text "A111";
 - 50.2.54) delete the number "85" and replace it with the text "A107";
 - 50.2.55) delete the number "68" and replace it with the text "A108";
 - 50.2.56) delete the number "38" and replace it with the text "A104";
 - 50.2.57) delete the number "68" and replace it with the text "A107";
 - 50.2.58) delete the number "1" and replace it with the text "A101";
 - 50.2.59) delete the number "24" and replace it with the text "A103";
 - 50.2.62) delete the number "39" and replace it with the text "A104";

50.2.63) delete the number "142" and replace it with the text "A111";

50.2.64) delete the number "118" and replace it with the text "A108";

50.2.65) delete the number "145" and replace it with the text "A112";

50.2.66) delete the number "65" and replace it with the text "A106";

4. This By-law shall come into force and be deemed to come into force in accordance with subsection 34(21) of the Planning Act, R.S.O. 1990, c. P.13, either upon the date of the passage of this by-law or as otherwise provided by the said subsection.
