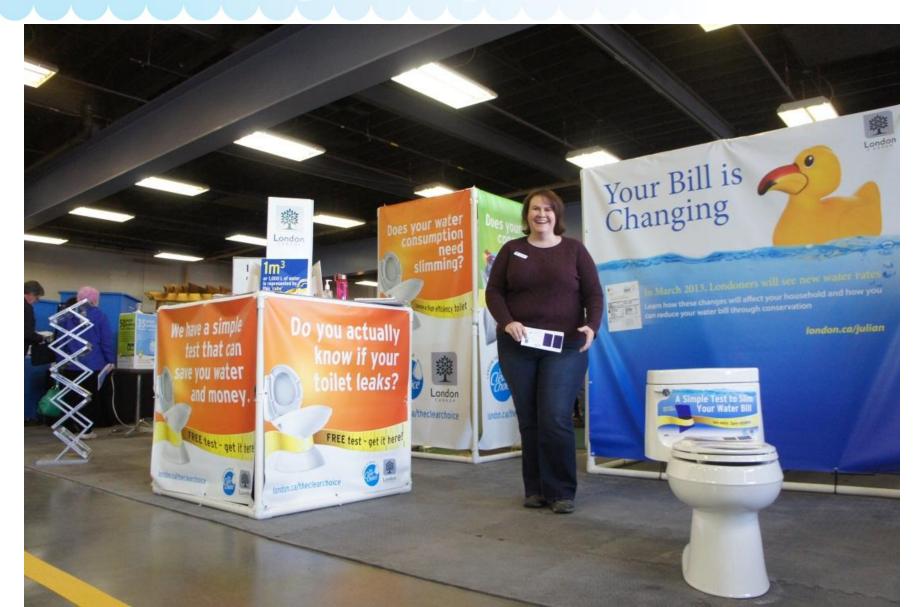

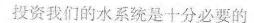

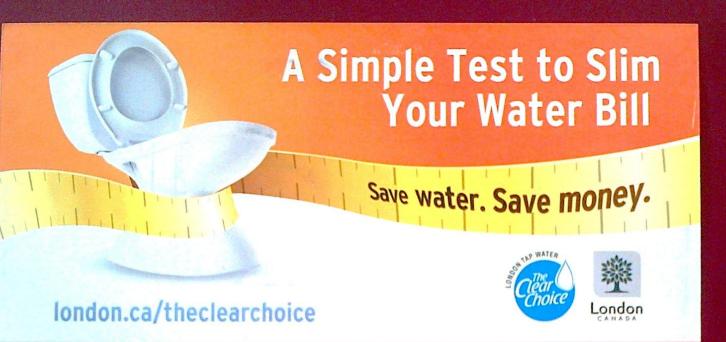

leak test strips

Each year a **leaky toilet** can waste more than 200,000 litres of water — enough to fill a large swimming pool.

This simple test could help you save water and save money.



#### PEEL AND TOSS

We've enclosed two non-toxic dye test strips (to test two toilets). Flush the toilet. As it's refilling, peel one strip and place it into the toilet tank.

#### WAIT AND CHECK

Wait 20 to 30 minutes and check the water in your toilet bowl. If it is blue, you have a leak. Often the fix is very simple.

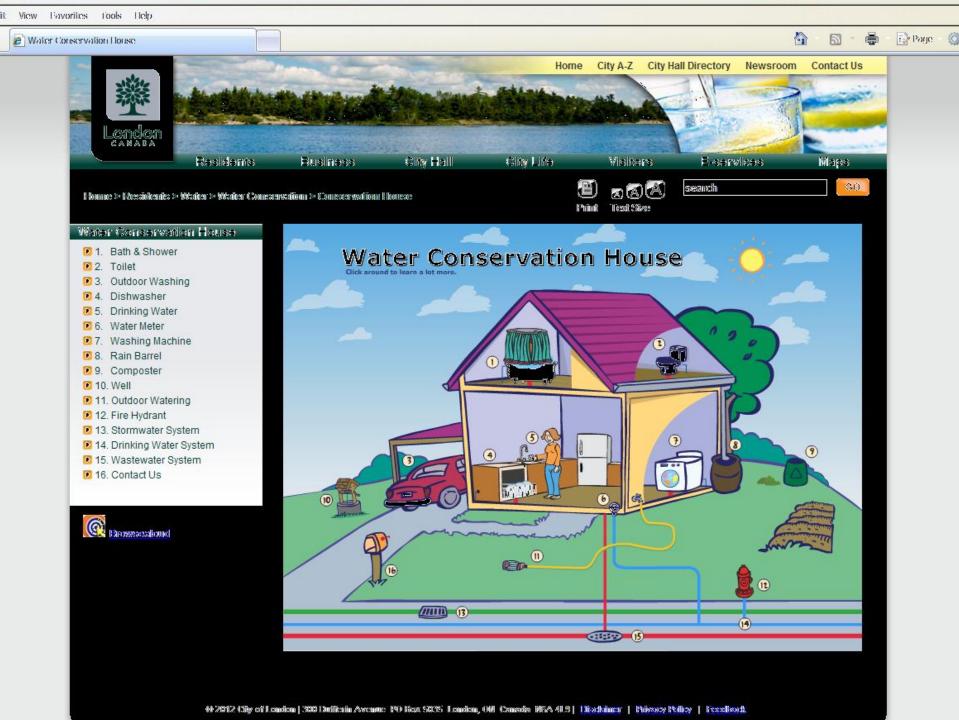

### Comments and complaints

- City received ~250 e-mails and phone calls – 0.23% of our customers
- About 45 topics were identified
- About 38 viewed as positive responses
  - Found leaks, educational, interested in more information



#### Comments and complaints (cont'd)

- Highest frequency included:
  - 31 Customer assistance program
  - 22 Think they have a leak
  - 21 Fire protection charge
  - 15 Already paying too much
  - 14 Property size & meter size?
  - 11 Not enough detail on bill



#### **London Hydro Call Centre**

- LH classifies calls by topic
- Of the 472 "water only" calls:
  - 124 related to new rates & bill format
    (0.11% of our customers) majority
    related to the two-line bill format
  - 226 related to potential & confirmed leaks

- Rates & Charges are now "schedules" to the main by-laws
- New definitions and clarifications
- Consistency and modernization



#### Vacant parcels - no storm charge

- Currently, if a property does not have a water or wastewater account, they pay nothing for storm drainage
- This customer inequity resulted when the storm drainage charge was moved from the tax base to stormwater utility base
- New by-law proposes to re-instate the charge January 2015, following consultation with stakeholders.
