A by-law to amend By-law A-44, being a by-law respecting the Civic Administration, to change the title of "Managing Director, Housing and Social Services" to "Managing Director, Housing, Social Services and Dearness Home", to better reflect the portfolio of the position.

WHEREAS subsection 5(3) of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, provides that a municipal power shall be exercised by by-law;

AND WHEREAS section 9 of the *Municipal Act, 2001* provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

AND WHEREAS it is deemed expedient to pass this by-law;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

- 1. By-law A-44 entitled "A by-law respecting the Civic Administration" be amended in the Table contained in section 4 of the by-law, by deleting under "Service Area Leads" the title "Managing Director, Housing and Social Services" and replacing it with the title "Managing Director, Housing, Social Services and Dearness Home".
