AND WHEREAS the Municipal Council considers it desirable to enforce and seek compliance with the designated by-laws, or portions of those by-laws, through the Administrative Monetary Penalty System;

AND WHEREAS the Municipal Council on June 25, 2019 passed By-law No. A-54, being "A by-law to implement an Administrative Monetary Penalty System in London:"

AND WHEREAS the Municipal Council deems it appropriate to amend Bylaw No. A-54 with respect to contraventions of designated by-laws under the Administrative Monetary Penalty System By-law;

NOW THEREFORE the Council of The Corporation of the City of London enacts as follows:

- 1. That Schedule "A-1" of the By-law be replaced with the new <u>attached</u> Schedule "A-1";
- 2. That Schedule "A-2" of the By-law be replaced with the new <u>attached</u> Schedule "A-2";
- 3. That the definition of "Hearing Officer" in section 1.1 of the By-law be deleted and replaced with:
 - "means a person who performs the functions of a Hearing Officer in accordance with Section 6 of this By-law, and pursuant to the City's Hearing Officer By-law, A.-6653-121, as amended from time to time;"
- 4. That the definition of "Penalty Notice Date" in section 1.1 of the By-law be deleted and replaced with:
 - "means the date of the contravention specified on the Penalty Notice, in accordance with section 3.3 of this By-law;"
- That the definition of "Review by Hearing Officer and Hearing" in section1.1 of the By-law be deleted and replaced with:
 - "mean the process set out in section 6 of this By-law:"
- 6. That the definition of "Review by Screening Officer and Screening Review" in section 1.1 of the By-law be deleted and replaced with:
 - "mean the process set out in section 5 of this By-law;"
- 7. That the definition of "Screening Decision" in section 1.1 of the By-law be deleted and replaced with:

"means a notice which contains the decision of a Screening Officer, delivered in accordance with Section 5.13 of this By-law;"

8. That the definition of "Screening Officer" in section 1.1 of the By-law be deleted and replaced with:

"means a person who performs the functions of a Screening Officer in accordance with section 5 of this By-law, appointed by the City as per Schedule "C"."

9. This by-law shall come into force and effect on the day it is passed.
