By-law No. PS-111-_____

A by-law to amend By-law PS-111 entitled, "A by-law to regulate traffic and the parking of motor vehicles in the City of London."

WHEREAS subsection 10(2) paragraph 7. of the *Municipal Act, 2001*, S.O. 2001, c.25, as amended, provides that a municipality may pass by-laws to provide any service or thing that the municipality considers necessary or desirable to the public;

AND WHEREAS subsection 5(3) of the *Municipal Act, 2001*, as amended, provides that a municipal power shall be exercised by by-law;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

1. No Parking

Schedule "2" (No Parking) of the said By-law PS-111 is hereby amended **by removing** the following row:

2. Stop Signs

Schedule "10" (Entering Highway – Stop Signs on specified streets) of the said By-law PS-111 is hereby amended by **adding** the following row:

Northbound & Southbound	Chelton Road	Meadowgate Boulevard

Eastbound & Westbound	Meadowgate Boulevard	Chelton Road

3. Yield Signs

Schedule "11" (Entering Highway – Yield Signs on specified streets) of the said By-law PS-111 is hereby amended by **adding** the following rows:

Northbound & Southbound	Turner Crescent	Asima Drive (east intersection)
-------------------------	-----------------	---------------------------------

Northbound	Turner Crescent	Asima Drive (west intersection)
------------	-----------------	---------------------------------

4. Through Highways

Schedule "13" (Through Highways) of the said By-law PS-111 is hereby amended **by deleting** the following row:

Meadowgate Blvd	Commissioners Road E	Asima Drive
--------------------	----------------------	-------------

And **by adding** the following row:

Meadowgate Boulevard	Commissioners Road E	Chelton Road
-------------------------	----------------------	--------------

Meadowgate Boulevard	Chelton Road	Asima Drive
-------------------------	--------------	-------------
