SUBJECT	AMENDMENTS TO THE TRAFFIC AND PARKING BY-LAW

### **RECOMMENDATION**

That on the recommendation of the Acting Director, Roads & Transportation, the <u>attached</u> proposed by-law (Appendix "A") **BE INTRODUCED** at the Municipal Council meeting to be held on December 5, 2011 for the purpose of amending the Traffic and Parking By-law (P.S. 111).

#### **BACKGROUND**


The Traffic and Parking By-law (P.S.111) requires amendments (Appendix "A") to address traffic safety, operations and parking concerns. The following amendments are proposed:

#### 1. Regulatory Signs

- a) All Way Stop Signs Right-of-way control should be changed to an all-way stop control at the following locations:
  - The intersection of Nicole Avenue and South Wenige Drive has met the warrant for an all-way stop control.
  - The intersection of Nicole Avenue & Stackhouse Avenue/Stackhouse Crescent experiencing operational problems since current intersection configuration does not allow for proper right-of-way control. It is proposed to install an all-way stop control at this intersection for safety reasons and to direct traffic.

Amendments are required in Schedule 10 (Stop Signs) and Schedule 11 (Yield Signs).

- b) Stop Signs New stop signs are required to address right-of-way control at the following intersections:
  - A new school crossing will be installed across Nicole Avenue at Stackhouse Crescent (west intersection). The existing yield sign on Stackhouse Crescent should be replaced with a stop sign to facilitate the change. Amendments are required in Schedule 10 (Stop Signs) and Schedule 11(Yield Signs).
  - Wickerson Gate at intersection with Wickerson Road. An amendment is required in Schedule 10 (Stop Signs).
- c) Yield Signs Right-of-way control is required in a new residential development at new intersections. Amendments are required in Schedule 11 (Yield Signs) for the following locations:
  - Brayford Crescent with Ironwood Road
  - Crane Avenue with Pioneer Parkway
  - Loyalist Court with Loyalist Place
  - Maidstone Lane with Bayham Lane
  - Romney Lane with Maidstone Lane
  - Tyson Walk with Brayford Crescent
  - Wickerson Gate with Brayford Crescent



#### 2. Through Highways

Yield and Stop controls should be in place for streets intersecting Settlement Trail between Pack Road and Raleigh Boulevard. Initially these intersections will be controlled by Yield Signs which may be changed to Stop Signs as traffic volumes increase. It is proposed to designate Settlement Trail as a through Highway. An amendment is required to Schedule 13 (Through Highways).

Stop controls should be in place for streets intersecting Pack Road from Homewood Lane to Col. Talbot Road and again from Col. Talbot Road and Bostwick Road. Traffic on Pack Road is required to stop at Col. Talbot Road. It is proposed to designate Pack Road as a through Highway. An amendment is required to Schedule 13 (Through Highways).

Due to ongoing safety concerns on Coronation Drive with respect to intersecting streets controlled by yield signs it is proposed to designate Coronation Drive as a through Highway. Existing yield signs at intersecting side streets can be replaced with stop signs as warranted. Amendments are required to Schedule 10 (Stop Signs), Schedule 11 (Yield Signs) and Schedule 13 (Through Highways).

# 3. No Parking Zones

## a) Adare Crescent

At the request of residents, a mail-back survey was conducted on Adare Crescent to determine if the homeowners supported prohibiting parking on the west/north sides of Adare Crescent from Commissioners Road East to High Street. The results of the mail-back survey indicated that the majority of respondents supported the parking regulation change. An amendment is required to Schedule 2 (No Parking).

#### b) Andover Drive

Due to safety concerns with vehicles parked within the southbound right turn lane on Andover Drive at Southdale Road it is proposed to create a No Parking anytime zone on the west side of Andover Drive from Southdale Road to 40 meters north. An amendment is required to Schedule 2 (No Parking).

# c) Clenray Place


At the request of residents, a mail-back survey was conducted on Clenray Place to determine if the homeowners supported prohibiting parking on the east side of Clenray place from Regent Street to the North end of the street. The results of the mail-back survey indicated that the majority of respondents supported the parking regulation change. An amendment is required to Schedule 2 (No Parking) and Schedule 6 (Limited Parking).

#### d) Fairview Ave

At the request of residents, a mail-back survey was conducted on Fairview Avenue to determine if the homeowners supported prohibiting parking on the west side of Fairview Avenue from Alexandra Street to Bond Street. The results of the mail-back survey indicated that the majority of respondents supported the parking regulation change. An amendment is required to Schedule 2 (No Parking).

# e) Pond View Road

Due to safety concerns with vehicles parked within a newly created pedestrian refuge lane along a rural section of Pond View Road it is proposed to remove the existing No Parking 8am-6pm zone and implement a No Parking anytime zone on the east/north side of Pond View Road from North Pond Court to Glenroy Road. An amendment is required to Schedule 2 (No Parking).



#### 4. No Stopping Zone

Due to pedestrian safety concerns in front of St. Jude Catholic School at 690 Viscount Road it is proposed to create a limited 8 am - 9 am and 3 pm - 4 pm No Stopping zone on the north side of Viscount Road from Notre Dame Drive to Galloway Crescent. Concerns have been expressed that students are crossing Viscount Road from the north side of the road in places other than a pedestrian crosswalk after being dropped off or for pick up. An amendment is required to Schedule 1 (No Stopping).

#### 5. Higher Speed Limits

#### a) Fanshawe Park Road West

Fanshawe Park Road West is currently posted at 80 km/hr between Stanton Drive and Wonderland Road North and 70 km hr between Wonderland Road North and Derwent Road It is recommended to reduce the speed limit to 60 km/hr from 250 meters east of Wonderland Road North to Aldersbrook Road and to 70 km/hr from Aldersbrook Road to Stanton Drive due to recent residential and commercial development in the area.

# b) Southdale Road West

Southdale Road West is currently posted at 80 km/hr between Boler Road and Wonderland Road North. It is recommended to reduce the speed limit from Boler Road to Talman Road to 60km/hr and from Talman Road to Wonderland Road North to 70 km/hr due to recent residential development in the area.

Amendments to Schedule 17 (Higher Speed Limits) are required.

#### 6. <u>Unmetered Municipal Parking</u>

A new 56 stall public commuter parking lot has been recently constructed north of Bradley Avenue east of the Veteran's Memorial Parkway. Parking will be limited to 120 consecutive hours to correspond with the Ministry of Transportation commuter parking lot time restrictions. Parking will be restricted to passenger vehicles only. Amendments are required to Section 58 - Table 2 and Section 60 - Table 3 and Schedule 24 (Unmetered Parking Lots).

# 7. Typographical Errors

A review of the by-law found a typographical error. Changes are required to address the following:

- a) Designated Accessible Parking Spaces
- b) Heavy Trucks Restrictions on Decker Drive and Wonderland Road South
- c) Parking on Greenside Avenue

Amendments are required to Schedule 2 (No Parking), Schedule 14 (Heavy Truck Restrictions) and Schedule 27(Designated Parking Spaces-Disabled Persons).
