RECOMMENDATION

That on the recommendation of the Acting Director, Roads & Transportation, Environmental & Engineering Service that Civic Administration **BE AUTHORIZED** to undertake all administrative acts that are necessary to seek increased set fines for parking related offences as per Appendix "A".

BACKGROUND

PURPOSE:

On October 19th, 2001 the Service Review Committee recommended the following:

"That the Civic Administration **BE DIRECTED** to report back to the Services Review Committee with respect to a suggested fee schedule for increasing parking fines, to accommodate proportional fine increases that are related to the severity of the current fine, and for consistency; it being noted that any proposed fines are reviewed and implemented by the Chief Justice, as a set fine."

In order to ensure the fine changes are implemented in early 2012 as was suggested by the Service Review Committee (SRC), the following report is presented to the Built and Natural Environment Committee to expedite the application for approval by the Ontario Chief Justice. It reviews parking related fines and proposes two alternatives which respond to the Service Review committee recommendation. The final resolution from Municipal Council will be forwarded to the Service Review Committee at an upcoming meeting.


DISCUSSION:

With the exception of the fine for parking at an expired meter, London parking fines have remained unchanged since 1995. Parking fines are to be punitive in nature and should reflect the severity of the offence. The number of infractions has increased over the years which suggest the fine amount may not be enough of a deterrent. London fines are generally slightly below the Ontario Municipal Benchmarking Initiative (OMBI) median; the proposed changes would put them at slightly above the median.

A number of options were considered by staff when determining the amount of the proposed fine increases. These were narrowed down to the following two options:

Option 1 - \$5 fine increase

- All fines are increased by at least \$5
- Some higher increases to match similar offences (achieves direction as requested by SRC)
- Assumes a 5% reduction in the number of tickets due to improved compliance
- Based on the number and type of tickets issued in 2010 the average increase in fines would be \$5.87



Option 2 - \$10 fine increase

- Most fines are increased by \$10
- Fines for expired meters remain unchanged at \$20
- Some higher increases to match similar offences
- Assumes a 7.5% reduction in the number of tickets with fine increases due to improved compliance
- Based on the volume of tickets issued in 2010 the average increase in fines would be \$5.21

SUMMARY:

When the Service Review Committee considered proposed fine changes in the 2012 Parking Business Plan, it requested a review of proportional changes to existing fines. The proposed changes strive to achieve compliance with the parking by-laws and equity by making fines the same for similar offences.

The 2012 Parking Operating Budget includes increased revenues through fine increases. The 2012 anticipated budget impact is -\$240,000 based on changes being made in early 2012.

It is recommended that the fines for parking related offences be increased as per Option 1 which is a smaller base increase than Option 2.






