## I YOUR COMMITTEE RECOMMENDS:

Heritage Alteration Application – M. Furmston 1. (4) That, on the recommendation of the Director of Land Use Planning and City Planner, with the advice of the Heritage Planner, the Heritage Alteration Permit Application of M. Furmston requesting permission for alterations to the designated heritage property located at 340 St. James Street **BE APPROVED**; it being noted that the Heritage Planner has reviewed the proposed alterations to the building, including a demolition of an existing garage and its replacement and has advised that the impact of such an alteration on the heritage features of the property identified in the reasons for designation is negligible; it being further noted that the London Advisory Committee on Heritage (LACH) heard a verbal delegation from M. Furmston, with respect to this matter.

Heritage Conservation District Priority List - Evergreen and Riverview Area 2.
