Mayor Fontana and Members of Committee,

This letter is to confirm the LDI's agreement with the Staff recommendations in the report to the Committee before you today. The LDI has been part of the Development Charges (DC) Stakeholder Committee reviewing DC policies along with City Staff, the London Home Builders Association and the Urban League.

There has been a collaborative effort made by all parties involved with the review of the DC policies and Lyn Townsend has done an excellent job of facilitating the process with additional support and technical expertise from Gary Scandlan of C.N. Watson.

The recommendations highlight a major change in the way the development industry will operate in the future with the retirement of the Urban Works Reserve Fund (UWRF) and all future DC funded works being built under the City Services Reserve Fund (CSRF) tied to the Capital budget through the Growth Management Implementation Study (GMIS).

The success of these changes to the DC funds will be contingent on the implementation of the enhanced GMIS strategy included in the Staff recommendations. The revised strategy provides for a more collaborative approach to the annual GMIS update and the ability to monitor the DC funds to ensure that the DC rate is accurate to be able to finance the proposed works.


It is imperative that Lyn Townsend should be involved in the first GMIS update to ensure that the founding principles as set out in Appendix "A" are met and to see through to completion the recommendations in the Staff report.

The proposed Municipal Service and Financing Agreement (MSFA) Policy will provide a vehicle to allow DC funded works to be advanced through a Front Ending Agreement (FEA) to permit the industry and the City to be able to meet changing market demands or business opportunities that benefit the community. It is recognized that the need for a FEA will be limited with the proper implementation of the GMIS.
